Change Order No. 1 to SRS Engineering Inc. PO No. 78741

City Code Section 2-845 Change Orders - Upon the award of any contract for the construction of any public service building or capital improvement project, the city manager shall have the authority to approve change orders without prior city commission action in an amount not to exceed five cumulative percent of the contract price or \$25,000.00, whichever is less.

Resolution 15-008 approves a Master Service Agreement with SRS Engineering Inc. (SRS) for providing design and CEI services of 20 Bus Aprons along US1 between Key West and Marathon.

Engineering Services recommends that the City of Key West issue SRS a change order for the survey and design of 4 alternate bus locations. Due to FDOT currently constructing 2 bus aprons and objecting to 2 locations, of which all 4 locations were previously reviewed and approved by all stakeholders and SRS performed preliminary surveying and design. The additional fees for SRS providing surveying and design of these 4 alternate locations is \$8,230.00. This amount is 5% of the original Agreement/Purchase Order number 78741's \$ 165,000 value.

An adequate funding level exists in Transit System Fund account #411-4404-544.65-00 / Project Code TS1102 for funding this change order value. Upon approval, a change order to purchase order 78741 would be issued to SRS for \$8,230.00.

We appreciate this opportunity to prepare this Notice of Intent to provide additional services for the referenced project in accordance with our professional services contract. The added scope of work, consists of additional engineering design and surveying services required due to changes in selection of new bus apron sites as indicated in letters dated July 1, 2015 and July 24, 2015 which revised Appendix 1 amending the Master Services Agreement for the four previously selected KWDOT bus apron site locations. Please see attached Letters dated July, 1 2015, and July 24, 2015 for additional information.

Our Additional Services will consist of:

Additional Engineering Services:

- Conducting site visits to 4 new bus apron locations to observe existing conditions.
 (1hr Sr.Mgr (\$138/hr) + 1hr Sr.Eng (\$108/hr) = \$246.00)
- Attending additional meeting with FDOT associated with new locations.
 (1hr Sr.Mgr (\$138/hr) = \$138.00)
- Coordination with Surveyor.(1hr Sr.Mgr (\$138/hr) + 1hr CAD (\$70/hr) = \$208.00)
- Coordination with Mote Marine Lab for location of bus stop.
 (1hr Sr.Mgr (\$138/hr) = \$138.00)

Additional Surveying Services:

Preparation of topographical survey for the following four alternate sites:

- Ramrod Key- FKAA MM27 Reference ID NB 25
- Middle Torch Key Opposite SR4A Reference ID NB 27
- Big Coppitt Key-FKAA Plant MM10 Reference ID NB 13
- Summerland Key-Mote Marine Lab Reference ID NB23
- Provide additional topographical survey for the Lobstertail Rd and SR5 site. We are proposing to shift the bus apron farther south and will need a survey for that portion

AMEC shall commence surveying within 5 days for notice to begin and shall complete the all sites within 15 days thereafter. Completed survey sites shall be provided to SRS as they are complete and SRS will begin designing as we received them. We expect to have all remaining 5 sites completed within 5 days of receiving the last site or a total of 25 days after NTP.

As requested, please consider this document as our proposal to provide professional surveying and mapping services related to the above referenced project. Please find below and on the following pages our understanding of the project surveying needs, proposed scope of services, schedule to complete the work and estimated fee to provide the described services and products.

Project Understanding

Amec Foster Wheeler (AMEC FW) has assisted SRS in the completion of this project with the preparation of topographic surveys for selected bus apron locations. It is our understanding that now there are four (4) alternative sites that require survey. These sites are identified on Attachment A 1-4 as:

- Ramrod Key- FKAA MM27- Reference ID NB 25
- Middle Torch Key Opposite SR4A (Actually on Little Torch key)- Reference ID NB 2
- Big Coppitt Key-FKAA Plant MM10-Reference ID NB 13
- Summerland Key-Mote Marine Lab-Reference ID NB23

Per Attachment B we also understand that there is a need for additional survey at a site that we had already surveyed; Lobstertail Rd. and SR5. It has been proposed to shift the bus apron farther south and as a result topographic survey will be needed for that portion of roadway.

Proposed Scope of Services

As we have done at the other bus stop sites we will perform a topographic survey to include all information as requested previously for each site including establishing survey control points relative to NAD83/2011 and NAVD88, location of above ground improvements and above ground evidence of utilities, existing bus stops, detailed survey of at least a 20 foot area outside the bus stop location, centerline elevations, location of apparent existing R/W lines, and grade breaks along the roadway shoulder. Also, as necessary, we will locate the areas adjacent to the individual work sites that may be environmentally sensitive based on existing vegetation or flagging provided by others.

Deliverable products will include an AutoCAD format digital file of each work site and composite Surveyor's Report for the work performed.

All services and products will be performed and compiled in accordance with Florida Administrative Code Rule Chapter 5J-17, Standards of Practice, pursuant to Chapter 472, Florida Statutes.

Schedule

We are currently in a position to commence work in 5 days from receiving a written Notice to Proceed . We will provide individual site surveys as they are completed with the final products to be delivered in 15 days after commencing the work.

Our estimated lump sum fee to provide the above described services and products is \$7,500.00



Thank you as well for having us at your office yesterday. Please read below a brief summary of our meeting with Patty lvey:

- <u>Marathon-42nd Street @ Hobbs County Park</u>- The improvements to this portion of US1 were already made by FDOT. We will have to adjust C&G in this area but otherwise Patty does not have an objection to this location. Patty mentioned that this portion of roadway may be under moratorium.
 - Patty, please elaborate as to how this will affect our apron construction at this location? What are the requirements for construction on the portion of FDOT roadway under moratorium?
 - You must 'match existing' in pavement type & thickness. There can be no cutting of the pavement (beyond the tie-in with the apron) without a full lane restoration for 100' (50' on either side of the cut). This will be included as a Special Provision in the FDOT Permit.
- Marathon-FHP Station @ Elementary School- Please see the attached upcoming FDOT project at 33rd and US1 (FHP Site). I have marked up the location in which the proposed bus stop apron would be. This project is proposing to widen US1 and add C&G at this location. Construction for this project is scheduled to start sometime in December 2016 and is estimated to last 250 days. Please confirm if you would like to proceed with Big Coppitt Key-FKAA Plant MM10 as the alternate for the FHP site.
- Ramrod Key-Past Looe Key Tiki Bar- This location is very tight. Between the existing edge of travel lane and the FKOHT there are 12'. This would suggest that the Bus Apron would encroach into the Bike Path lane which was one of Patty's concerns. The FKOHT is already adjacent to retaining wall on the south side due to the large drop off and shifting this FKOHT trail to the south is not an option. Would the City consider the alternate (Summerland key-Mote Marine Lab (NB#23)) in lieu of this site?
 - I don't like this site at all. Way too tight. There is not sufficient room on the unpaved shoulder and a transit stop so close to the intersecting sidestreet is not desirable. (see photo "Ramrod Key Looe Tiki").
- <u>Summerland key-Mote Marine Lab</u>- Patty mentioned that the Mote Marine Lab may have plans to relocate their existing driveway locations. This will affect the location of the proposed bus apron if it is chosen to proceed with. Patty is researching this and will notify us of her findings asap. This will have to be confirmed before we can send the surveyors out to this location.
 - I don't think you'll have to scratch this site, just slightly modify north or south depending on the Mote Marine future access point(s).

Therefore, if the City agrees with the above mentioned suggestions we will need (4) four additional surveys completed for the following sites pending Patty's findings:

Little Torch Key-Opposite SR4A (NB#27)





ACTION STATEMENT:

Resolution authorizing the City Manager to enter into a Master Agreement with SRS Engineering Inc. for Design and Construction Phase Services of 20 Lower Keys Bus Aprons for a not to exceed amount of \$165,000.

BACKGROUND:

The City received two responses to RFQ 14-001 for Design of Bus Aprons for the Lower Florida Keys bus routes. An evaluation committee consisting of City Staff considered respondent qualifications at a public session on March 17, 2014. Staff subsequently recommended to City Commission that SRS Engineering, Inc. be the first ranked for the negotiation of an Agreement with the City Manager as passed with Resolution 14-121.

PURPOSE AND JUSTIFICATION:

On May 7, 2014 the City Commission passed Resolution 14-121 which approved the staff's RFQ 14-001 Respondents ranking and authorized negotiations with the top ranked Respondent to enter into an Agreement with the City of Key West. The final negotiated SRS Engineering, Inc. fee breakdown for the 20 Lower Florida Keys Bus Aprons Project (Project Code TS1102) including design, engineering and construction phase services is:

OPTIONS:

There are two (2) options:

- 1. City Commission can approve the proposed Master Agreement and negotiated fee of \$165,000, and authorize the City Manager to execute the Agreement with SRS Engineering, Inc. for design, engineering, and construction engineering and inspection services of the 20 Lower Florida Keys Bus Aprons Project.
- 2. City Commission can reject proposed Master Agreement with SRS Engineering, Inc. for design, engineering, and construction engineering and inspection services of 20 Lower Keys bus aprons and direct Staff to negotiate with the next top ranked firm as listed in the provisions of Resolution 14-121.

FINANCIAL IMPACT

Funding for this project is available in account 411-4404-544.65-00 under project code TS1102 for \$ 165,000. The negotiated total design, engineering, and construction phase services fee shall not exceed \$ 165,000.

RECOMMENDATION

Staff recommends approval of Option 1.
