SECTION 2. That the Exclusive Sports Marketing, Inc. of Florida is hereby granted permission for the closure of certain streets throughout the city for the Key West Halloween Half Marathon & 5K Run on the date and during the hours stated above.

SECTION 3. That the Exclusive Sports Marketing, Inc. of Florida is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that

will take place and time herein described.
