#### The following additions, deletions, or revisions to the Work have been ordered and authorized:

#### Description of Work:

Work Change Directive 001 includes the following three changes:

- 1. City of Key West Building Department fees for Electrical, General, and Roofing Building Permit(s). Total Cost for this item is <u>\$1,974.15</u>.
- Cost for the replacement of the curbing and ventilation hoods on the lower portion of the Administration building which were found to be in a severely corroded condition. To assure longevity of the facility, and the roof repair, the decision was made to replace these under the current contract. Total Cost for this work is <u>\$6,322.47</u>.
- 3. The Fans in the old Chlorine building were found to be in a severely corroded and inoperable condition. They are no longer needed, so instead of replacing, the decision was made to remove fans and curbing, fill roof penetrations, and install new roof. This cost is for removing old hood curbing, doweling new reinforcement, filling hole with concrete, and finishing with roofing material. Total Cost for this work is \$5,359.20.

#### Total Proposed cost for this work change directive is \$13,655.82.

#### Reason for Change(s):

Permitting Costs not included in original Bid Documents

Existing hoods on lower portion of administration building were found in a severely corroded condition.

Ventilation fans and roof mounted exhaust hoods on the old chlorine building were found in severely corroded condition. Since the installation of the UV treatment system, chlorine is no longer used, and these exhaust fans are no longer required.
