A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RESCINDING CITY COMMISSION RESOLUTION 16-213; APPROVING THE ATTACHED "AGREEMENT FOR THE CONVEYANCE OF REAL PROPERTY" BETWEEN THE CITY OF KEY WEST AND THE SCHOOL BOARD OF MONROE COUNTY FOR THE REMAINING SCHOOL DISTRICT OWNED STRUCTURES AT THE FORMER GLYNN ARCHER SCHOOL; PROVIDING FOR AN EFFECTIVE DATE

in order for the City to acquire, and the School Board to release, the remaining portion of the Glynn Archer School site; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Resolution No. 16-213 and approval of the Agreement attached thereto is hereby rescinded.
