A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A PURCHASING EXCEPTION PURSUANT TO SECTION 2-797(1) AND 2-797(4) OF THE CODE OF ORDINANCES, TO ALLOW AN INCREASE NOT TO EXCEED \$8,397.00 IN CUMULATIVE EXPENDITURES DURING FY 17 TO EDDIE LOPEZ TECHNOLOGIES, LLC D/B/A STOP OCEAN POLLUTION ON A SOLE SOURCE BASIS (INCREASE PURCHASES FROM THIS VENDOR TO A TOTAL OF \$28,077.00); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, after testing filters from the only known curb inlet filter manufacturers, City staff determined that Eddie Lopez Technologies, LLC d/b/a as Stop Ocean Pollution is the sole source provider for the purchase and installation of heavy duty aluminum curb inlet filters for type 5 and 6 inlets for the stormwater drainage system; and

WHEREAS, the City Manager finds that pursuant to sections 2-797(1) and 2-797(4), it is in the best interest of the City to authorize an increase of the amount of authorized expenditures for sole source vendor Stop Ocean Pollution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of 13 Aluminum Curb Inlet Filters from Stop Ocean Pollution is authorized in the amount of \$8,397.00 (in addition to \$19,680.00 in purchases from this vendor to date) as a sole source procurement, pursuant to Key West City Code of Ordinances section 2-797(1) and 2-797(4), best interests of the City.

Section 2: That adequate funds for this purchase are budgeted in line item 402-3802-538-4600.

<u>Section 3</u>: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
