A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDING THE BID OF A-1 PROPERTY SERVICES, INC. FOR THE MARTIN LUTHER KING JR. COMMUNITY CENTER ROOF REPAIR PROJECT IN AN AMOUNT NOT TO EXCEED \$177,037.00 IN ACCORDANCE WITH THE TERMS SPECIFIED IN ITB THREE 017-010, INCLUSIVE OF ADDITIVE ALTERNATES (INSTALLATION OF SOLAR HEAT/COOLING SYSTEM FOR \$14,449.00; INSTALLATION OF SEALOFLEX LIQUID ON ENTRY ROOF \$4,500.00; INSTALLATION OF LIGHTNING PROTECTION FOR \$7,250.00); AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT ON BEHALF OF THE CITY OF KEY WEST; AUTHORIZING NECESSARY BUDGET AMENDMENTS AND TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on October 26, 2016 two responsive bids were opened in response to ITB #017-010, for the Martin Luther King Community Center Roof Repair Project, with A-1 Property Services, Inc. submitting the lowest bid; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of A-1 Property Services, Inc. for the Martin Luther King Community Center Roof Repair Project in an amount not to exceed \$177,037.00, in accordance with ITB No. 017-010, inclusive of three additive alternates ((1) Installation of

Solar Heating/Cooling System at \$14,449.00; (2) Installation of Sealoflex Liquid on Entry Roof at \$4,500.00 and Installation of Lightning Protection at \$7,250.00), is hereby approved.

Section 2: That project funding in the total amount of \$200,000.00 is budgeted in account No. 101-7201-572-6200 (Project No. IS72011601). A transfer of additional funds in the amount of \$14,435.90 from Infrastructure Surtax Reserves account No. 101-1900-519-9400 is hereby authorized.

Section 3: That the City Manager, upon consent of the City Attorney, is authorized to execute a contract in substantial conformance with the bid documents on behalf of the City of Key West.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
