An application was received requesting the removal of **(1) Gumbo Limbo tree**. A site inspection was done on November 30, 2016 and documented the following:

Tree Species: Gumbo Limbo (Bursera simaruba)

Diameter: 8.9"

Location: 60% (growing under the canopy of a larger gumbo limbo, trunk against fence)

Species: 100% (on the protected tree list)

Condition: 60% (fair-one sided canopy and trunk misshaped due to larger tree canopy)

Total Average Value = 73%

# Value x Diameter = 6.4 replacement caliper inches

The gumbo limbo that is being requested to remove will never have a proper canopy due to the closeness of the larger gumbo limdo and with future growth, will become very on side (with its weight primarily to one side).

Recommendation: Recommend approval of the removal of one (1) Gumbo Limbo tree at 925 Fleming Street to be replaced with 6.4 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.


