A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH JOHN R. OLSEN, MANAGING PARTNER OF ARCPE I, LLC, PROPERTY OWNER(S) OF 1523 SEMINARY STREET, PERMITTING A RELEASE OF LIEN UPON PAYMENT BY THE OWNERS OF THE AMOUNT OF \$2,000.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, a property lien in the total amount of \$12,750.00, resulting from fines accrued in Code Compliance File No. 16-774, was promulgated upon owner of record, Elsa Diaz, and Mortgage Contracting Services; and

WHEREAS, on November 18, 2016, compliance was achieved and daily fines were discontinued, and on November 28, 2016, Code Compliance received a Request for Release of Lien from the new property owner, John R. Olsen, as Managing Member of ARCPE I, LLC; and

WHEREAS, Barry R. Brecher, who has power of attorney to negotiate the amount of the fine for the owner, has offered \$2,000.00 to settle the fine.

WHEREAS, on January 4, 2017, the City Commission considered the owner's request to release the lien imposed on the property.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Manager, upon the advice and consent of the City Attorney, is authorized to enter into an agreement with John R. Olsen as Managing Member of ARCPE I, LLC, the owner(s) of the property known as 1523 Seminary Street, to allow the City's release of lien upon payment of an amount of \$2,000.00.

Section 2: That the property owner shall pay the reduced lien amount of \$2,000.00 within thirty (30) days of the date of this Resolution as a condition precedent to the reduction of the \$12,750.00 lien amount.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
