An application was received requesting the removal of **(2) Avocado and (1) Sapodilla tree**. A site inspection was done on December 20, 2016 and documented the following:

Tree Species: Avocado (*Persea americana*)





Diameter: 16.5"

Location: 60% (canopy impacted by utility lines)

Species: 100% (on protected tree list)

Condition: 30% (poor, hole in main trunk goes all the way through-hollow trunk, structurally lopsided)

Total Average Value = 63%

Value x Diameter = 10.3 replacement caliper inches

Avocado Tree #2













Diameter: 23.8"

Location: 50% (utility line impacts with feeder going right through canopy)

Species: 100% (on protected tree list)

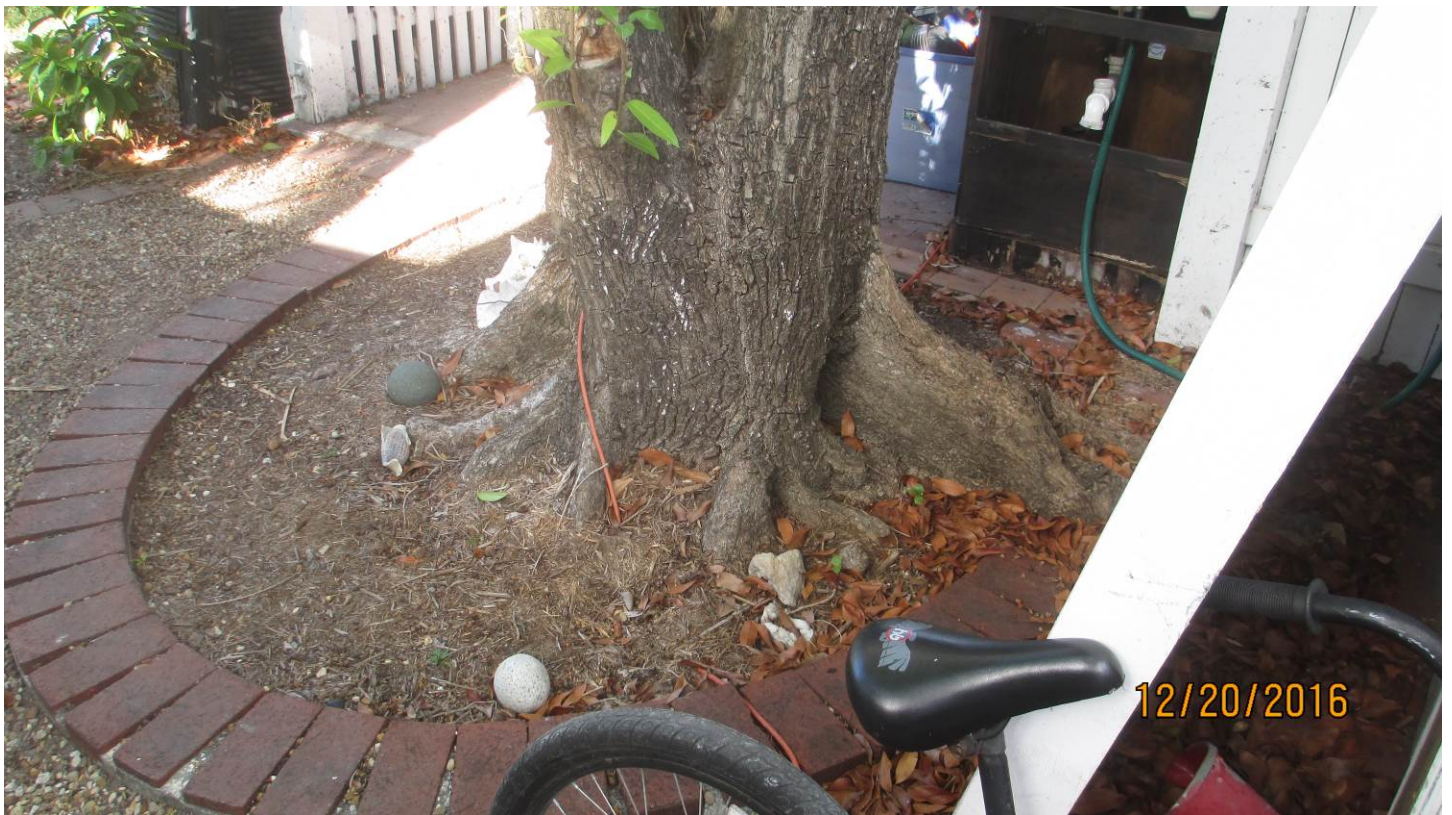
Condition: 30% (poor, two main trunks/branches with decay in both trunks, decay in structural roots)

Total Average Value = 60%

Value x Diameter = 14.2 replacement caliper inches

Tree Species: Sapodilla (Manilkara zapote)









Diameter: 34.3'''

Location: 70%

Species: 100% (on protected tree list)

Condition: 40% (poor, three codominant trunks, lots of poor cuts in canopy)

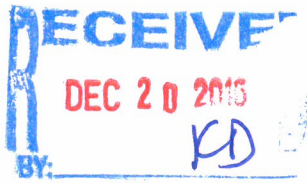
Total Average Value = 70%

Value x Diameter = 24 replacement caliper inches

Applications were submitted and approved for removal of these same trees in 2010 (T10-5594 issued October 14, 2010) and 2014 (T14-6727 issued March 12, 2014) by the Tree Commission appointed at those times.

Recommendation: Recommend approval of the removal of two (2) Avocado and one (1) Sapodilla tree at 1210 Duncan Street to be replaced with a total of 48.5 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.

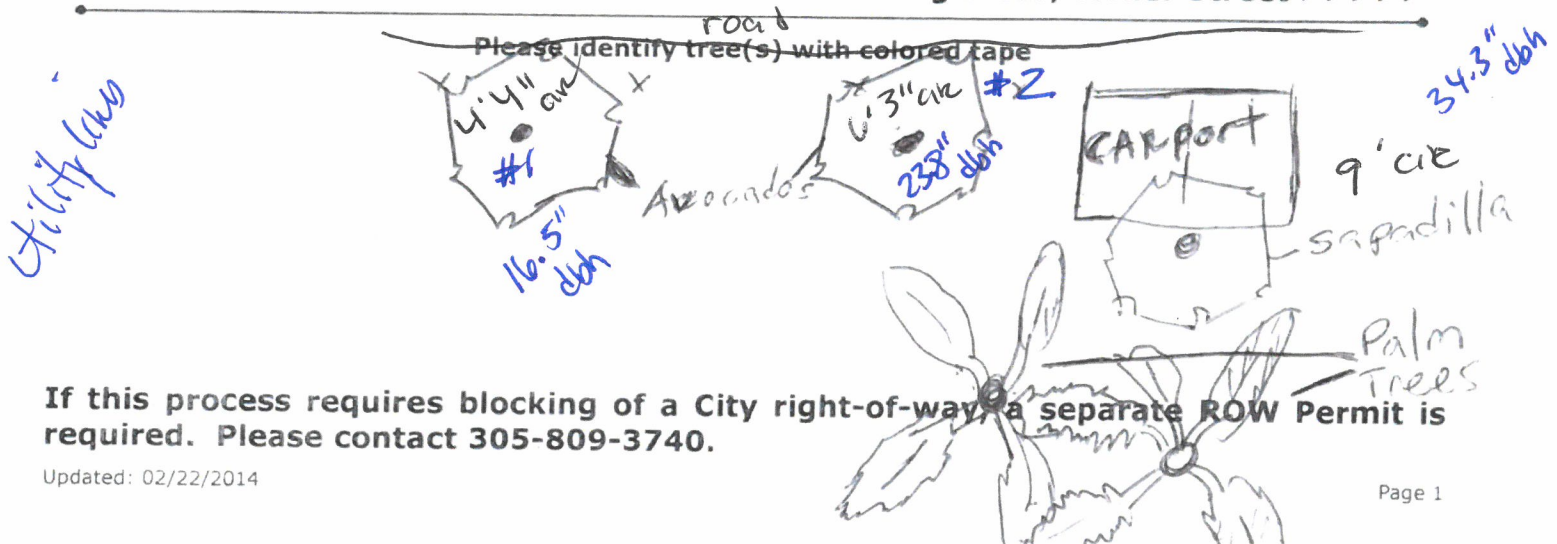
