A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF TWO (2) FORD F250s AND ONE (1) FORD EXPLORER IN A TOTAL AMOUNT NOT TO EXCEED \$88,965.00 FROM DUVAL FORD FLEET SALES, THROUGH PIGGYBACKING ON THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES BID NO. FSA16-VEL24.0 CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE BY THE KEY WEST UTILITIES (SEWER) DEPARTMENT; AUTHORIZING NECESSARY BUDGET TRANSFERS FOR THE PURCHASE OF ONE FORD F-250; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this purchase will be made under the Florida Sheriffs Association and Florida Association of Counties Bid No. FSA16-VEL24.0, pursuant to section 2-797(3) of the Code of Ordinances;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of two (2) Ford F-250 trucks and one (1) Ford Explorer, described in the attached proposal of Duval Ford Fleet Sales, pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association and Florida Association of Counties Contract, in an amount not to exceed \$88,965.00, is hereby authorized for the Utilities (Sewer) Dept.

Section 2: That a budget transfer in an amount not to exceed \$34,434.00 from Sewer operating reserves to account number 401-3503-535-6400 for the purchase of one Ford F-250 is hereby authorized.

Section 3: That funds are already budgeted for one Ford Explorer and one Ford F-250 in FY 16/17 under account number 401-3503-535-6400.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
