A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF FOUR (4) FORD F250s AND ONE (1) FORD F-350 IN A TOTAL AMOUNT NOT TO EXCEED \$172,395.00 FROM DUVAL FORD FLEET SALES, THROUGH PIGGYBACKING ON THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES BID NO. FSA16-VEL24.0 CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES, FOR USE BY THE KEY WEST PUBLIC WORKS DEPARTMENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this purchase will be made under the Florida Sheriffs Association and Florida Association of Counties Bid No. FSA16-VEL24.0, pursuant to section 2-797(3) of the Code of Ordinances;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of four (4) Ford F-250 trucks and one (1) Ford F-350 truck, described in the attached proposal of Duval Ford Fleet Sales, pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association and Florida Association of Counties Contract, in an amount not to exceed \$172,395.00, is hereby authorized for use by the Public Works Department.

Section 2: That funds are budgeted in FY 16/17 under account number 001-1905-519-6400.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
