An application was received requesting the removal of **(1) Royal Poinciana tree**. A site inspection was done on January 17, 2016 and documented the following:

Tree Species: Royal Poinciana (Delonix regia)





















Diameter: 21.9"

Location: 40% (Impacting historic house foundation, canopy in utility lines)

Species: 100% (on protected tree list)

Condition: 50% (fair to poor, tree has a poor structure)

Total Average Value = 63%

Value x Diameter = 13.7 replacement caliper inches

**Additional information requested verbally from property owners—
photos of foundation issues under the house, additional information
regarding health of tree, and information regarding issues with
utility access from pole to house.**

**There are several other existing canopy trees on the property
(Sapodilla and a Strangler Fig) that will remain.**

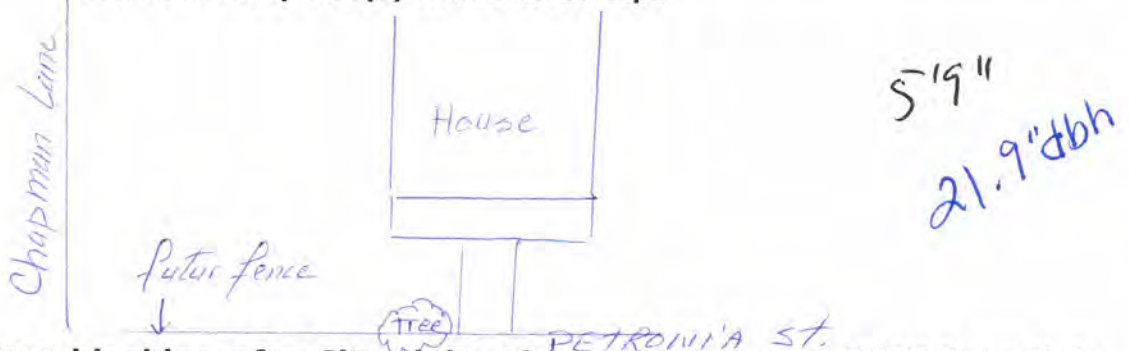
