South Roosevelt Boulevard needs two new bike lanes and a turning lane. Seventy percent (70%) of the participants at a recent public workshop supported a change, and the Florida Department of Transportation (FDOT) is ready to pay for the cost. But Key West City staff is against the changes and is urging the City Commission to keep the road in its current state.

South Roosevelt is one of the island's most popular roadways, providing access to Smathers Beach and recreation area for pedestrians and cyclists. It is also one of the most dangerous, with 2 fatalities caused by reckless driving in the last 12 months. The wall at the end of the intersection with Bertha Street has been struck by reckless drivers countless times. Without a dedicated bike lane, many cyclists use the sidewalk, limiting the space available to pedestrians and beach-goers.

FDOT wants to make South Roosevelt safer and better for all. They need the City Commission's approval and support on their recommended changes. We are adding our voices to the 70% majority that supported these changes at the public workshop.

To the Key West City Commissioners, please vote NO on Agenda item 23 at your February 7th meeting and allow FDOT to make South Roosevelt safer.

As the morning progresses more traffic occurs with the onset of the morning commute. I ride in the road on the far right edge where I'm supposed to. Many times, cars drive next to me and do not give me the required 3 foot clearance. Surprise wind gusts have often caused me to move a few feet from the edge. If one of the close passing cars was there at the time of the wind gust, we would have hit. The speed signs have been up in both directions over the last few weeks. Cars are constantly driving fast causing the signs to flash speeds ranging from 35 to the low 40's for nearly every car. The speed limit is 30. Also, many fast cars are weaving in and out of the two lanes and passing cars that are going the speed limit. The new road design, as illustrated, will keep bicycle riders safer and lower vehicle speeds. The single lane will lower speeds. It will prevent cars from weaving back and forth between the lanes to pass drivers who are abiding by the 30 mph limit. The dedicated bicycle lanes will give the riders the cushion and space they need, especially with wind gusts along South Roosevelt. The clearly dedicated lanes will give vehicle drivers and bicycle riders clear vision where the bicycle should safely ride. The door opening lane, that is adjacent to the parking spaces, will prevent a vehicle owner from opening their vehicle door as the cyclist passes. I've avoided several car doors opening as I approached. Many other cyclists have not been so fortunate and have ridden into doors that opened in their path. Please change the lanes to make South Roosevelt safer for cyclists, drivers and pedestrians. Thank you
