# New MDP in the approval process with DRC

Major Development Plan - 801 Eisenhower Drive (RE#00023190-000000 ;AK# 1023965) – Major Development Plan application for renovation of an existing two story office building to include ten new transient units.

Major Development Plan and Conditional Use - 2312-2318 North Roosevelt Boulevard (RE# 00065720-000000 ;AK# 1068560, RE# 00065730-000000 ;AK# 1068578 ) – Major Development Plan and Conditional Use application for redevelopment of two existing parcels for the construction of a mixed use restaurant and retail development to include ten affordable housing units.





Major Development Plan - 5711 College Rd. for SPCA is moving forward,  
Considering Public Art installation recommendations from their architect,  
met with AIPP Administrator

Major Development Plan – 921 Truman  
Avenue, Seven Fish Restaurant,  
designated ‘Complete and Compliant’,  
installation exceeded 1% calculation.









# 1315 WHITEHEAD ST

---

- Due to vandalism, theft, and related destruction of physical property the installation at 1315 Whitehead St was temporarily removed from its mount by the property owner.
- The owner is seeking an alternative location on the property to re-install the Public Art (see attachment).

# MEMORIAL FOUNTAIN

---

- Fountain is in good working order
- AI PP has facilitated collaboration between the donor estate and the various City Departments
- Community Services will assume the maintenance responsibilities
- Maintenance Funds have been provided by the estate for 2 years in the amount of \$8000
  - Deposited into CFI 10 as a reserve to drawn upon as needed
  - Process to make funds available to Community Services for maintenance is being coordinated through the Finance Department

# FAPAP, STATE, AND NATIONAL COUNCIL OF THE ARTS MEMBERSHIPS

# FLORIDA COUNCIL ON ARTS AND CULTURE

---

- The Florida Council on Arts and Culture is the 15-member advisory council appointed to advise the Secretary of State regarding cultural grant funding and on matters pertaining to culture in Florida.
- Appointments to the Council are determined by the Governor, President of the Senate and Speaker of the House, in consultation with the Secretary of State. The Governor manages seven seats that serve four-year terms. The President and Speaker manage four seats each, with terms of two years. The appointments are based on geographic representation, as well as demonstrated history of community service in the arts and culture.
