A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER UNDER THE CITY'S ENVIRONMENTAL ENGINEERING SERVICES CONTRACT WITH TETRA TECH, AMOUNT NOT TO IN A TOTAL \$47,700.00 FOR PRE-CONSTRUCTION AND CONSTRUCTION ENGINEERING/INSPECTION SERVICES FOR THE TRUMAN ANNEX/NOAA SEAWALL PROJECT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 14-359, the City Commission approved a three-year Environmental Engineering Services contract with Tetra Tech, Inc.; and

WHEREAS, pursuant to Resolution 15-333, Tetra-Tech substantially completed the conceptual design, engineering standards and permitting for the Truman Annex/NOAA Seawall Project No. 004-17; and

WHEREAS, in Resolution No. 16-201 the City Commission accepted partial project funding from Enterprise Florida, Inc. for the Florida Defense Support Task Force, and in Resolution 17-007, the City Commission accepted partial project funding from the National Marine Sanctuary Foundation, additionally, the U.S. Navy provided an authorization letter for In-Kind funding; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a task order for Pre-Construction and Construction Engineering/Inspection Services for the Truman Annex/NOAA Seawall Project, under the City's Environmental Engineering Services Contract with Tetra Tech, Inc. is hereby approved in an amount not to exceed \$47,700.00.

Section 2: For this project budgeted funds will be allocated from account 101-4303-543-6300 Project TR1503.

<u>Section 3</u>: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
