On Monday, December 5, 2016 at approximately 2024 hours, I (Ofc. A. Rodriguez) responded to 1725 Catherine Street in reference to a possible crash.

Upon arrival, I met with John Binns who told me a male on a scooter cut him off as he was traveling eastbound on N. Roosevelt Blvd. at the intersection of George Street.

Binns stated the male was traveling in the inside lane as he was traveling in the outside lane before being cut off. Binns told me he had to lay down his scooter when he was cut off. Binns told me he then followed the male south on George Street to 1725 Catherine Street.

Binns stated he only followed the male to obtain his license plate number and was then attacked by the male who then went into the residence of 1725 Catherine Street.

As I spoke with Binns, I noticed a moderate odor of an alcoholic beverage coming from his breath and person. Binns also had minor cuts to his face and had a cut to his left knee that he described as road rash.

There was no evidence of a crash occurring and I did not see any damage to Binns' scooter or Binns' person that would indicate he was involved in a crash on his scooter.

As I spoke with Binns, a male emerged from the property, identified as Michael Wirkner.

Wirkner had a large laceration above his left eye that had coagulated and was no longer bleeding. Wirkner also had bruising and some minor swelling to his face.

Wirkner told me he was traveling east on Truman Avenue after leaving a meeting and did pass Binns as he stated he was traveling
