I have been a resident of Key West for over 40 years. I'm in favor of a wine shop at 700 Eaton Street. I object to the adversity and hostility from some neighbors that I have witnessed. Some neighbors have launched a smear campaign in the community and on social media against my daughter, Jessica Downer, and my son-in-law, Mike Downer, by misrepresenting their wine shop as a "bar" and making other false accusations about their integrity and intentions to gamer opposition in the community and recant support.

I was friends with the former director of the Christian Science Society, Gloria Shaw, for many years. Gloria signed the letter of non-opposition to the Downer's plans for a wine shop at 700 Eaton dated December 1, 2015 on behalf of the society as the director after she met with the Downers and they discussed their plans with her. Unfortunately, the Society reversed their position in December 2016 and have been unwilling to discuss this with the Downers since.
