1Q17 Large Cap Growth Portfolio Manager Commentary

The 1st quarter of 2017 saw the “Trump” effect persist with significant gains to overall equity markets. A preference for growth stocks was also clearly evident with the Russell 1000 Growth Index returning 8.91% for the quarter. The tilt towards growth can be attributed to expectations on Trump’s pro-business and growth oriented fiscal policies. While the failure to pass the American Health Care Act may have hindered Trump’s agenda, the markets had a limited downside reaction to the event. The strategy returned 7.99%, underperforming the benchmark by 0.92%, as the shift towards growth names pushed investors away from the cheaper names in the benchmark that contributed to the previous quarter outperformance.

Performance Attribution

For the quarter, the best performing sector was Information Technology (+13%). The strategy had many of its best performing stocks from within this sector: Activision Blizzard (+39%), Adobe Systems (+26%), Apple (+25%), Broadcom (+24%) and Facebook (+23%) all rose significantly. These stocks benefitted from the possibility of cash repatriation from foreign countries which would allow for growth through stock buybacks and/or higher dividends. The strong performance in the IT sector was a detractor to relative performance against the benchmark as the strategy was underweight the benchmark’s IT sector weighting. Stock selection worked best in the Consumer Discretionary sector while holding names like Hasbro (+29%) and NVR (+29%) that benefitted from the improved economy. The majority of sectors had positive returns for the quarter.

The Energy and Telecommunications Sectors were the only two sectors in the Russell 1000 Growth Index with negative returns for the quarter. Verizon (-8%) was the culprit in the Telecommunications sector as a reduction of margins in the war for “unlimited” data plans and the uncertainty of the Yahoo purchase

weighed on the stock. The Energy Sector returned -8% for the quarter as oil prices fell. Our stock selection added value in the Energy sector by avoiding the worst performing names. A slight underweight relative to the benchmark weighting also contributed positively to relative performance.

Outlook

While the quarterly performance was less than the benchmark, we utilize factors that have proven to outperform over time. We continue to believe that the temporary underperformance will revert back and become an outperformance relative to the benchmark. The strategy is built on fundamentally sound core principles of lower valuation, higher growth, higher quality and momentum.

1Q17 Fixed Income Portfolio Manager Commentary

As expected in March, the Federal Reserve raised its benchmark overnight interest rate a quarter point to a range of 0.75% - 1.00%. Neel Kashkari, Minneapolis Fed President, was the sole dissenting vote as he argued that high inflation was not an imminent threat to the US economy. We expect Janet Yellen to remain cautious and move slowly in light of moderate economic growth. This is the third time the Federal Reserve has raised interest rates since the financial crisis. However, long term interest rates have been trading based on the outlook for policy change under the new administration. Long term interest rates will not move higher until it is perceived economic growth is sustainable leading to an increase with inflation.

On March 24th, several people from our investments team had the ability to listen to James Bullard (President and CEO, Federal Reserve Bank – St. Louis) speak in Memphis. One of the main takeaways from his presentation was his stark outlook for the US economy related to growth. Real GDP has averaged approximately 2.1% over the last seven years and it is unlikely the US enters a period of rapid expansion. Additionally, based on recent trends the first quarter of 2017 is on pace to be below 2%. Mr. Bullard also points to stalled growth related to employment, as both employment and hours worked growth has slowed down. The US will not experience accelerated growth unless it is driven by an increase in productivity. Mr. Bullard makes a strong case for a relatively low policy rate for the foreseeable future based on global dynamics, lack of labor productivity and inflation still hovering below 2%. One unknown that we are watching closely is the potential changes to corporate tax rates, the lowering of tax rates should decrease leverage and ultimately increase the after-tax cost of debt which would force corporate CFO's to reconsider capital structure policies. A decrease in leverage would imply issuance to decline, thus making corporates relative value to treasuries even more appealing.

The Bloomberg Barclays US Gov/Credit index increased +0.96% during the quarter. The Gov/Credit index slightly outperformed the Bloomberg Barclays Aggregate which was up +0.82% during the quarter. Long dated assets which struggled during January, posted strong gains in both February and March as the yield curve started to flatten. The Bloomberg Barclays US Intermediate Gov/Credit index increased +0.78% during the quarter. From a performance standpoint, risk across fixed income securities was the

corporate bonds outperformed treasuries and agencies. Similar to 2016, the lowest quality rating within investment grade (BBB) outperformed AAA investments during the quarter (+1.71% vs. +0.60%). As a sign of risk appetite in the markets, corporate bond issuance remains strong (up 9% year-over-year) and issuers have found it easy to raise money in the capital markets offering little concessions to investors. Top performing sectors during the quarter included: Metals/Mining (+4.4%), Home Construction (+2.94%) and Chemicals (+2.13%).

The rise in short term interest rates have made it easier to deploy cash and seek opportunities that meet or exceed the rate of inflation, a task that has been difficult the last several years. The path towards higher interest rates will be slow and measured because of factors we have been discussing for the last several years (slow growth and global deflation). We are forecasting long term interests to be stalled until we see coordinated economic growth strategies from the new administration to drive inflation higher. As global central bankers start to pull accommodation from the market, we would expect volatility to increase in the second half of 2017. The European Central Bank is reducing its monthly bond buying program and the Federal Reserve has hinted that they will begin the process of reducing their balance sheet. Those factors should lead to a rise in long term interest rates.

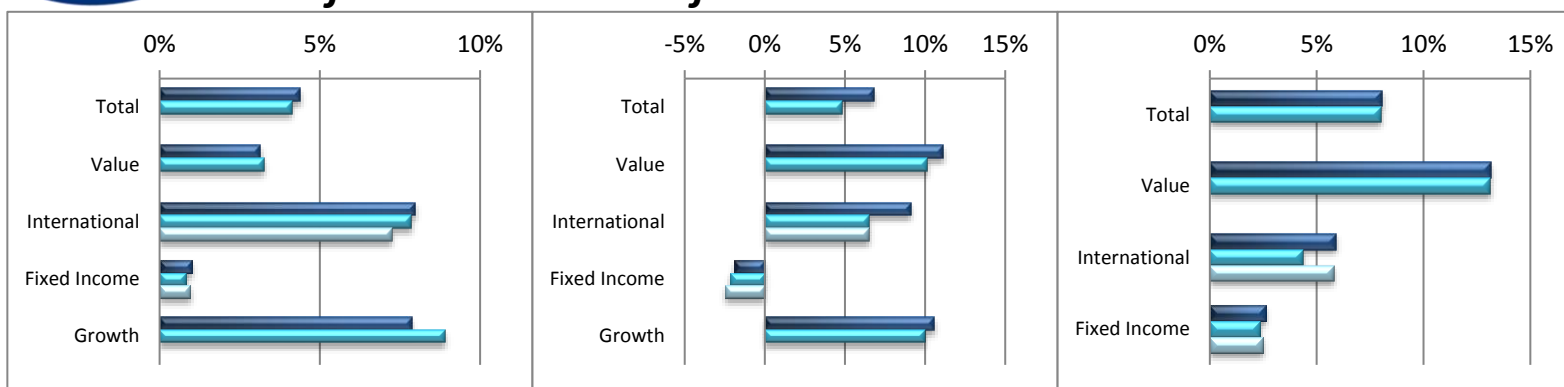

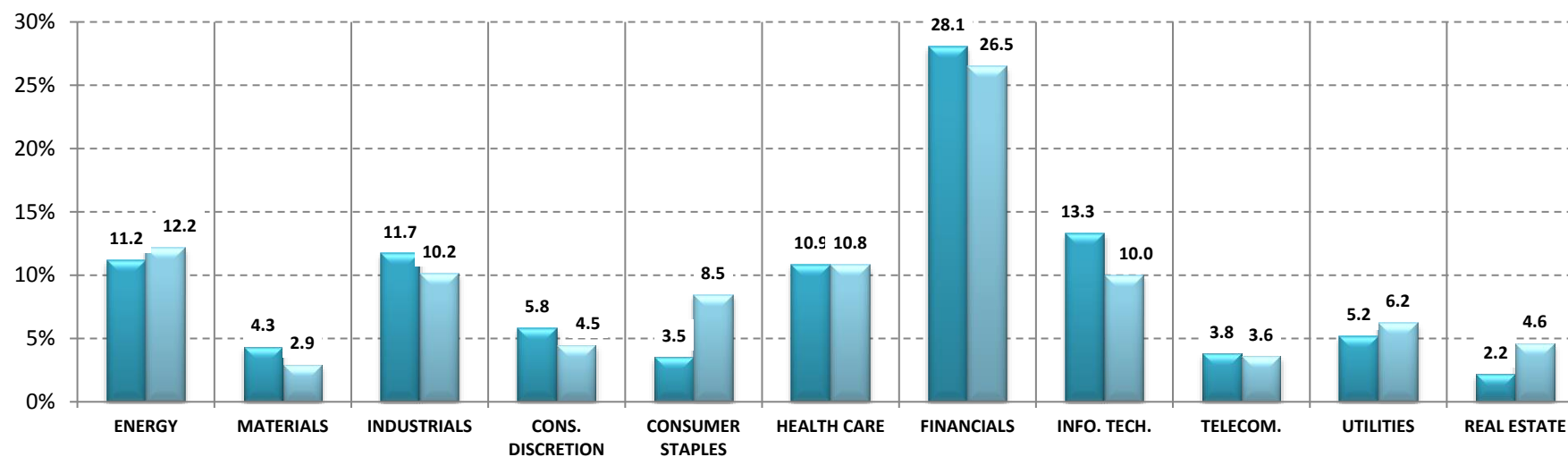

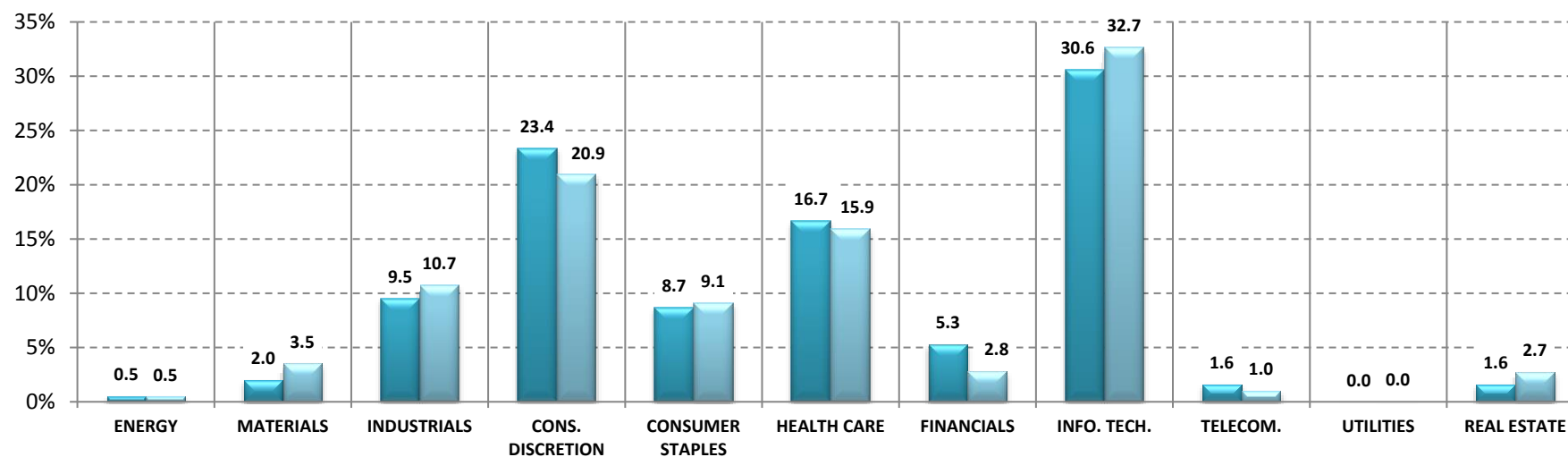
Domestic Equity Sector Allocation vs. R1000V



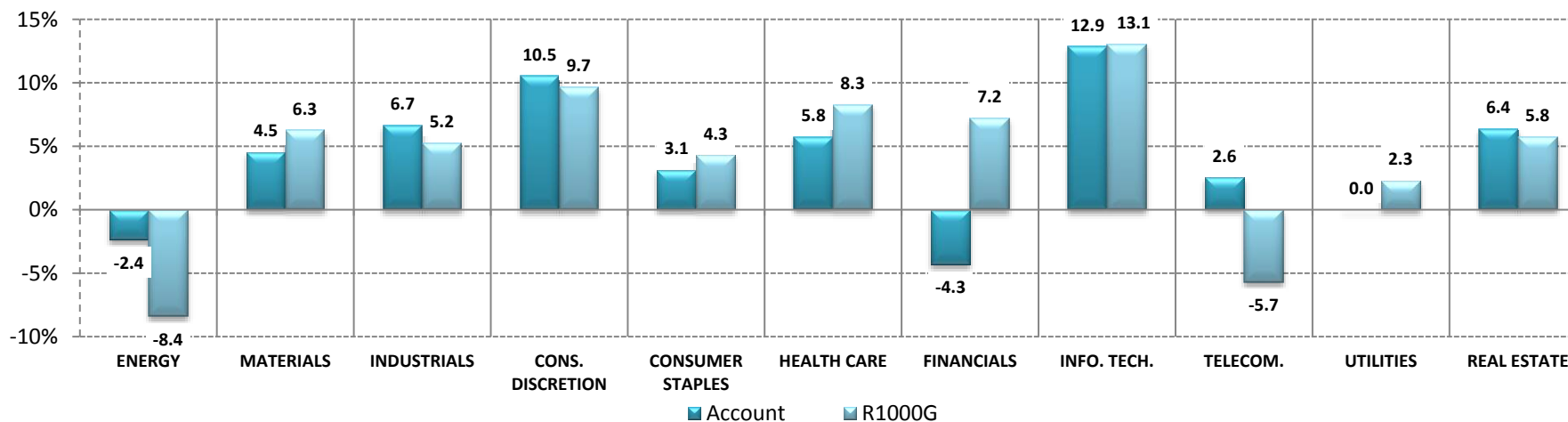
Domestic Equity Quarterly Sector Returns vs. R1000V



Domestic Equity Sector Allocation vs. R1000G

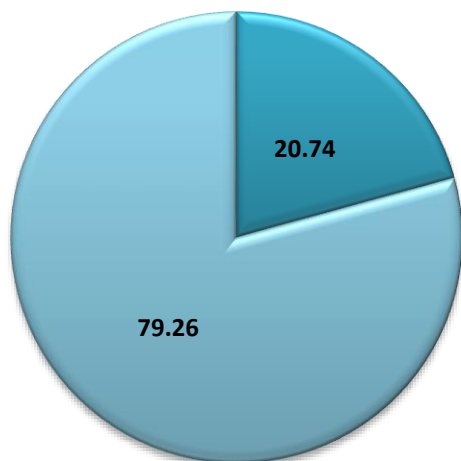


Domestic Equity Quarterly Sector Returns vs. R1000G

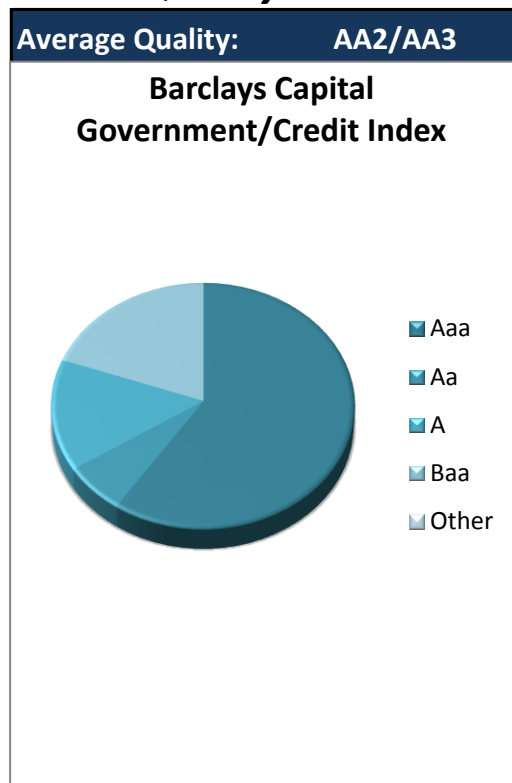
Fixed Income Sector Allocation



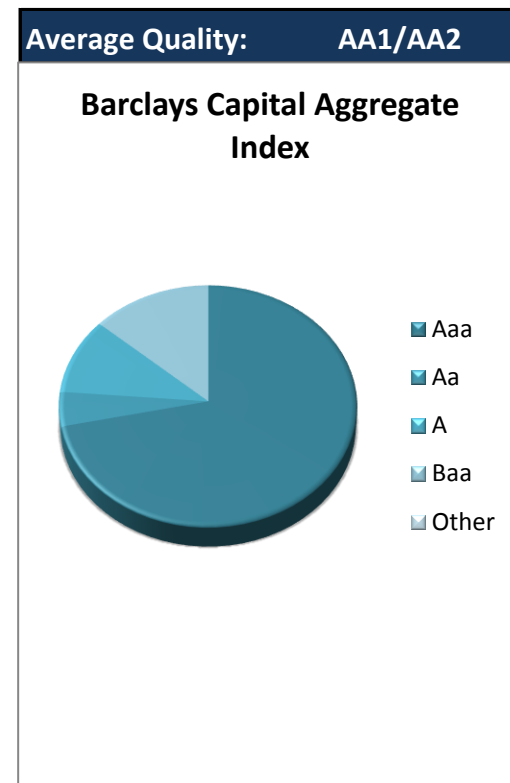

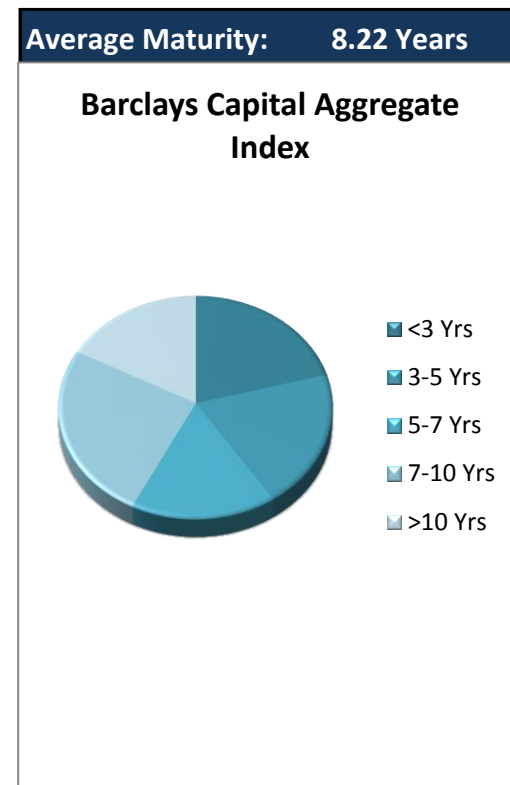
Bond Maturity Allocation

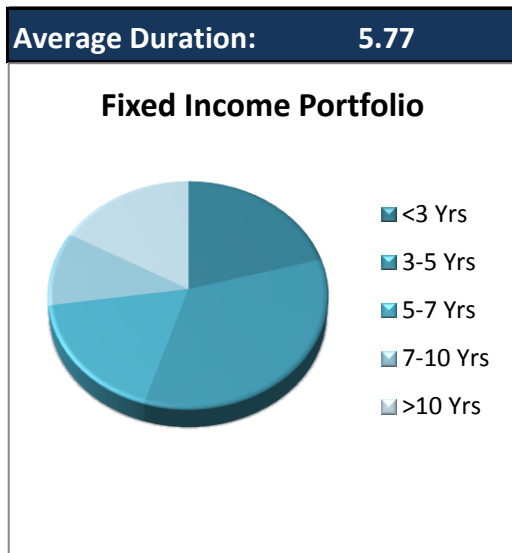

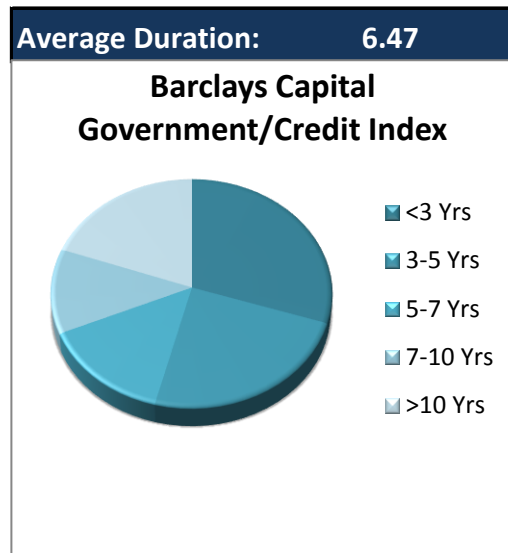

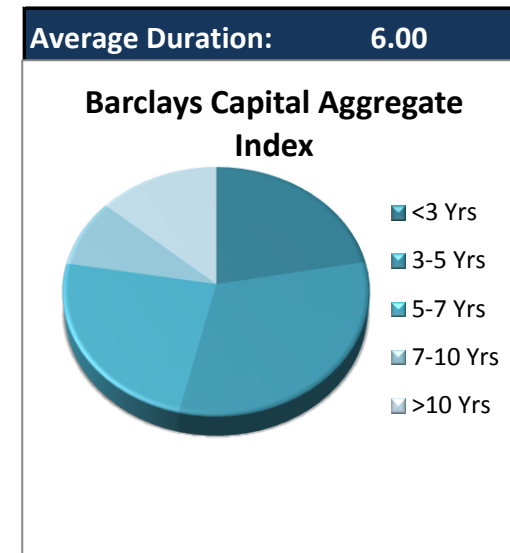
Duration Allocation



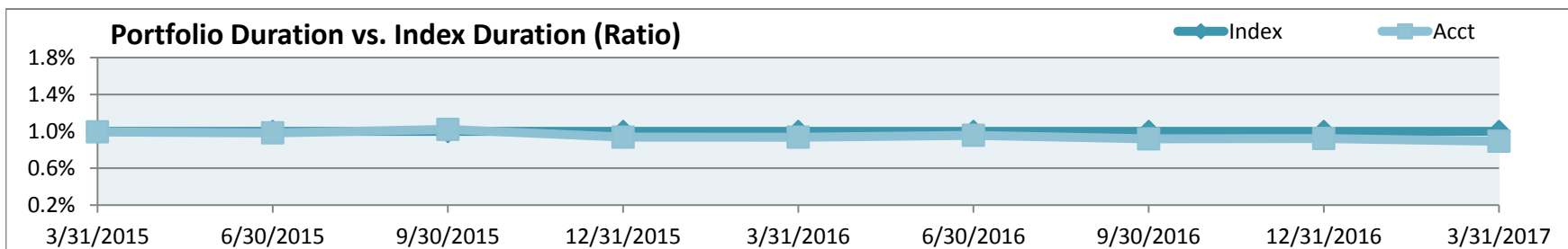
