A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, URGING COOPERATION BETWEEN THE KEY WEST GOOMBAY FESTIVAL, INC. AND FLORIDA KEYS PERFORMING AND VISUAL ARTS, INC; APPROVING AND AUTHORIZING ONE OF THE TWO APPLICANTS TO CONDUCT A GOOMBAY FESTIVAL ON OCTOBER 20 & 21, 2017 FROM 10:00 A.M. TO MIDNIGHT; AUTHORIZING THE CLOSURE OF PETRONIA STREET BETWEEN DUVAL STREET AND FORT STREET INCLUDING THE TRUMAN WATERFRONT RECREATIONAL FIELDS; AUTHORIZING THE CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA OF THE FESTIVAL; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES DURING THE FESTIVAL; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, two separate groups, the Key West Goombay Festival, Inc. and the Florida Keys Performing and Visual Arts, Inc., both submitted applications to conduct a Goombay Festival on Petronia Street from Duval Street to Fort Street including the Truman Waterfront Recreational Fields on Friday, October 20 & Saturday, October 21, 2017 between the hours of 10:00 a.m. to 12:00 midnight.

WHEREAS. The City Commission would appreciate these two groups finding a way to work together to conduct a Goombay Festival for the good of the community and its visitors rather than having to select between competing interests; and

WHEREAS, in the event the two groups are unable to find consensus before the June 6, 2017 City Commission meeting, the Commission will consider staff's recommendations as well as hear from the applicants;

NOW THEREFORE BE IT RESOLVED by the City Commission of the City of Key West Florida, as follows:

SECTION 1. [The Key West Goombay Festival, Inc.] [Florida Keys Performing and Visual Arts, Inc.] is hereby granted permission to conduct the event during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meets the terms and conditions set forth by the City Manager.

SECTION 2. That [The Key West Goombay Festival, Inc.] [Florida Keys Performing and Visual Arts, Inc.] is hereby granted permission for the closure of Petronia Street between Duval Street to Fort Street including the Truman Waterfront Recreational Fields on the date and during the hours stated above.

**SECTION 3.** That pursuant to Section 18-86 of the Key West Code Of Ordinances [The Key West Goombay Festival, Inc.] [Florida Keys Performing and Visual Arts, Inc.] is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

SECTION 4. That [The Key West Goombay Festival, Inc.] [Florida Keys

Performing and Visual Arts, Inc.] is hereby granted a Special Event Permit under Section 6-86

of the Key West Code of Ordinances for an event that will take place and time herein described

SECTION 5. That [The Key West Goombay Festival, Inc.] [Florida Keys]

Performing and Visual Arts, Inc.] will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 6.** That all neighboring property owners and/or tenants shall be notified of the events and the date, time and sound ordinance exemption.

SECTIOIN 7. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
