An application was received requesting the removal of **(1) Sea Grape tree**. A site inspection was done on June 22, 2017 and documented the following:

Diameter: 28"

Location: 80% (back yard tree)

Species: 100% (on protected tree list)

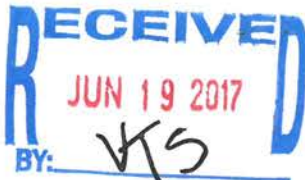
Condition: 20% (very poor, insect galls throughout tree, decay, poor structure, old bad cuts in canopy)

Total Average Value = 66%

Value x Diameter = 18.4 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Sea Grape tree at 3716 Donald Avenue to be replaced with 18.4 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.

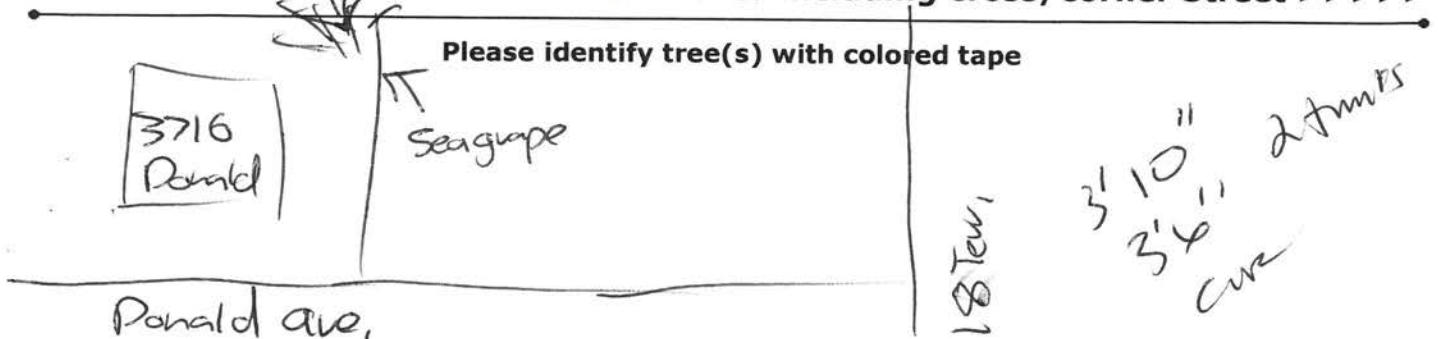

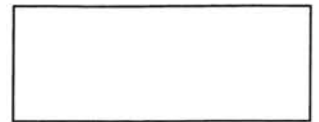

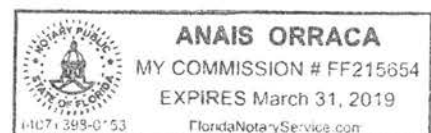
