

An application was received requesting the removal of **(1) Woman's Tongue tree**. A site inspection was done on June 19, 2017 and documented the following:

Tree Species: Woman's Tongue (Albizia lebbeck)


















Diameter: 26" - 24" = 2" regulated

Location: 20% (canopy impacting electrical transformer, roots growing

toward foundation of historic building and wall)

Species: 0% (on not protected tree list)

Condition: 60% (fair health with poor canopy structure due to constant

trimming from electrical lines)
Total Average Value = 26%

Value x Diameter = 0.5 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Woman's Tongue tree at 511 Caroline Street to be replaced with 0.5 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.
