

An application was received requesting the removal of **(1) Spanish Lime tree**. A site inspection was done on June 23, 2017 and documented the following:

Tree Species: Spanish Lime (Melicoccus bijugatus)



Diameter: 8.2"

Location: 50% (close to house, under canopy of other trees-Spanish lime and rubber tree, 4 other young Spanish lime trees growing along property

line to remain)

Species: 100% (on protected tree list)

Condition: 30% (very poor, trunk has been girdled-bark removed)

Total Average Value = 60%

Value x Diameter = 4.9 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Spanish Lime tree at 1037 Catherine Street to be replaced with 4.9 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.
