**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING OHWOOK PRODUCTIONS, INC. TO CONDUCT AN AMERICANA FOLK COUNTRY MUSIC FESTIVAL AT THE TRUMAN WATERFRONT AMPHITHEATRE ON FEBRUARY 7-10, 2018 FROM 3:00 P.M. TO 1:00 A.M.; ( SET UP STARTING ON FEBRUARY 7, 2018); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCE FROM 3:00 P.M. TO 1:00 A.M; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Ohwook Productions, Inc. wishes to conduct a Country Music & Americana/Folk Music Festival at the Truman Waterfront Amphitheatre between the hours of 3:00 p.m. to 1:00 a.m. on February 7-10, 2018; and

**WHEREAS**, this event shall take place on the grounds of the Truman Waterfront Amphitheatre during the hours of 3:00 p.m. to 1:00 a.m. on February 7 - 10, 2018; and

**WHEREAS**, the sponsors anticipates that amplified music will be played during the event;

**NOW THEREFORE, BE IT RESOLVED**, by the City Commission of the City of Key West, Florida;

**SECTION 1.** That Ohwook Productions, Inc. is hereby granted permission to conduct a "Country Music Concert" on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the

City is executed; and the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of Ordinances, Ohwook Productions, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

**SECTION 3.** That Ohwook Productions, Inc.. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time herein described.

**SECTION 4.** that Ohwook Productions, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used that that they will be placed side by side.

**SECTION 5.** that Ohwook Productions, Inc. will be responsible for the user fee of 5,000.00, a 5,000.00 refundable deposit as well as any other cost associated with the event.

**SECTION 6.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
