**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE POWERBOAT P1-USA LLC TO CONDUCT A PERSONAL WATERCRAFT WORLD CHAMPIONSHIP JET SKI RACES OFF SMATHERS BEACH ON SATURDAY DECEMBER 9 AND SUNDAY, DECEMBER 10, 2017 (SET UP FRIDAY, DECEMBER 8) FROM 8:00 A.M. TO 5:00 P.M. AND THE USE OF THE WHITE STREET PIER FOR THEIR VIP AND RACE VILLAGE DURING THE EVENT; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS,** Powerboat P1-USA LLC wishes to conduct a Personal Watercraft World Championship Ski Races on December 9<sup>th</sup> and 10<sup>th</sup> from 8:00 a.m. to 5:00 p.m.

**WHEREAS,** Resolution 96-311 prohibits commercial use of the White Street Pier n/k/a Ed Knight Pier.

**NOW, THEREFORE, BE IT RESOLVED,** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That the Powerboat P1-USA LLC is hereby granted permission to conduct the event as an exception to Resolution 96-311; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the city is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of Ordinances, the Powerboat P1-USA LLC is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

**SECTION 3.** That Powerboat P1-USA LLC is hereby granted permission for use of Smathers Beach to launch the watercraft and the use of the White Street Pier for Race Village and VIP area on the date and during the hours stated above.

**SECTION 4.** That the Powerboat P1-USA LLC will adhere to the recycling plan of the City of Key West and that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 5.** This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
