Cleaning is worst single sing so No rinse and sanitize options. Food is allowed to drop below safe temps for well past recommended guidelines. When NO ONE could be gotten in touch with during hurricane and I made decision to open shelter John terminates my employment AFTER I contact board members. That in and of itself is Serious whistle blower violation. John Miller is dishonest and deceitful. If our board does not take action against John Miller I would strongly suggest city THATS YOU SAM actually go out look at Beds washers cameras watch how and where food is prepped and cleaned. Also theres been over 17 scabies cases this year john claims not from Kots but when you are there as long as I was weekly you Know those cases originated at kots. If he lied to your face about these 2 list what else is he hiding. I do not reghret my decision to open shelter bit early after hurricane PEOPLE NEEDED IMMED SHELTER at the time! Jim if u saw fellow naval personell in distress would you await a order if you were in position to lend assistance? Same thing when a 6 yr old and his mom was in street. I make almnost 6 figure from my day job KOTS was a labor of love. No more Drugs there no more booze there Theft to a bare minimum My efforts drew community support and made Kots 100% safer and friendlier cleaner. John Miller is undermining that with gross mismanagement of funds earmarked for shelter operation. See attached list to determine his honesty or lack there of! Nobody relocated is allowed back EVER so that's yet another lie he has told commissioners may city managers! Step up handle this clown. My next stop personally will be whistle blower lawsuit and TV news interview! I am Done with Mr. Miller!
