A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT APPROVED BY THE CITY MANAGER IN EXCESS OF \$20,000 AS ALLOWED UNDER SECTION 2-797(2) OF CITY'S CODE OF ORDINANCES, FOR THE PROCUREMENT FROM TROJAN TECHNOLOGIES OF A PROGRAMMABLE LOGICS CONTROL UNIT AND ASSOCIATED EQUIPMENT FOR THE ULTRAVIOLET DISINFECTANT SYSTEM AT THE WASTEWATER TREATMENT PLANT IN AN AMOUNT NOT TO EXCEED \$67,338.64; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, a Programmable Logics Control (PLC) Unit and associated equipment at the Wastewater Treatment Plant (WWTP) was damaged, due to wind driven rain that damaged electrical systems during Hurricane Irma, and prompt replacement of the PLC is essential to operation of the WWTP; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to authorize an emergency procurement in the amount of \$67,338.64 to ensure that necessary replacement/repairs are made expeditiously; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission, in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies an emergency procurement in the total amount of \$67,338.64 to Trojan Technologies for a PLC and associated equipment for the Wastewater Treatment Plant.

Section 2: That the purchase will be charged to account 001-1910-519-6500, Project number HU1701F02.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
