A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING PURSUANT TO SECTION 7-797(4)(B) AND 7-771(3)(c) OF THE CODE OF ORDINANCES THE ATTACHED PROPOSAL OF MURRAY MARINE, INC. TO PURCHASE a 20' 2018 BLUEWAVE BAY BOAT WITH ENGINE AND TRAILER FOR USE BY THE KEY WEST POLICE DEPARTMENT MARINE UNIT AT A COST OF \$5,000.00 PLUS THE TRADE-IN OF TWO SURPLUS VESSELS; PROVIDING FOR AN EFFECTIVE DATE

Section 2: That funds for the purchase are available in account no. 001-21011-521-6400.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
