A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "PUBLIC TRANSPORTATION JOINT PARTICIPATION AGREEMENT" (JPA) FOR CONTRACT GOS29 BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST IN THE AMOUNT OF \$43,580.00 TO BE USED TO PURCHASE NECESSARY FACILITY AND VEHICLE EQUIPMENT (LOCAL MATCH 20% VIA TOLL REVENUE CREDITS); AUTHORIZING THE CITY MANAGER AND/OR TRANSIT DIRECTOR TO EXECUTE NECESSARY DOCUMENTS AND BUDGET AMENDMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, funding through FDOT, via the FTA Section 5339 Rural Bus and Bus Facility Capital funds, provides capital assistance for the purchase of support vehicles and/or needed equipment for the Key West Transit Facility; and

WHEREAS, in Resolution 17-146, the City Commission authorized certain members of City staff to apply for and accept grant funding, and to execute and submit grant documentation through the Transportation Electronic Award Management System and Florida Department of Transportation; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Public Transportation Joint Participation Agreement" (Contract #G0S29/FM #441865-1-94-01) is hereby approved, between FDOT and the City, for FTA Section 5339 Rural Bus and Bus Facility Capital Funds for the City of Key West DOT to purchase needed vehicle and facility equipment in an amount not to exceed \$43,580.00 (Local Match 20% via Toll Revenue Credits).

Section 2: That the City Manager is authorized to effectuate any necessary budget transfers in accordance with such grant agreement, and to execute any necessary documents.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
