A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT APPROVED BY THE CITY MANAGER IN EXCESS OF \$20,000 AS ALLOWED UNDER SECTION 2-797(1) and (2) OF CITY'S CODE OF ORDINANCES, FOR NECESSARY HURRICANE IRMA RELATED REPAIRS SET FORTH IN ITB #18-003 AT THE HISTORIC SEAPORT AT KEY WEST BIGHT BY EBSARY FOUNDATION CO. (EBSARY) IN AN AMOUNT NOT TO EXCEED \$389,000.00; AUTHORIZING ANY NECESSARY BUDGET AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Hurricane Irma made landfall in Key West on September 10, 2017, damaging pilings, docks and portions of the Harborwalk at the Historic Seaport; and

WHEREAS, the City Issued ITB 18-003, and two responsive bids were opened on November 22, 2017 and City staff recommends award of bid to the lowest responsive bidder, Ebsary; and

WHEREAS, due to life safety issues related to the hurricane damage, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to procure a contract for Ebsary to commence the work as soon as possible; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the City Commission, in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies the City Manager's emergency authorization for the procurement pursuant to ITB 18-003 in the total amount of \$389,000.00 from Ebsary Foundation Company.

Section 2: That the use of funds from Disaster Recovery Fund account 001-1910-519-6500, project HU1701G08-5196500, for Key West Bight Dock Repairs is authorized for this project.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
