A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER UNDER THE CITY'S GENERAL UTILITIES SERVICES CONTRACT WITH D.N. HIGGINS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$83,221.27 FOR NORTH ROOSEVELT OUTFALL REPAIR; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City staff and OMI determined that certain concrete light poles, installed by a contractor at the Gates Hotel/Latitude 24, obstruct City-installed outfall pipes that are part of the Donald Canal project and affect drainage of the canal and pond; and

WHEREAS, the Gates Hotel ownership and engineer are aware that their contractor is responsible for the damage, and City staff anticipates full recovery of expenses incurred for the investigation and repair of the damaged outfall; and

WHEREAS, in Resolution No. 15-292, the City Commission approved a three-year General Utilities Services contract with Douglas N. Higgins; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a Task Order for North Roosevelt Outfall Repair, under the City's General Utilities Contract with Douglas N. Higgins, Inc., is hereby approved in an amount not to exceed \$83,221.27.

Section 2: That funds for this project will be recovered from the responsible party, and any necessary budget adjustments are authorized.

Section 3: That the City Manager is authorized to execute necessary documents upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
