On 10/14/2017, at about 2033 hours, I saw a male later Identified as Clifton Harley Jr., riding a skateboard on the 1200 Block of Duval Street, heading the opposite direction from me. I recognized him to be a person a had previously warned for the same offense. At about 2043 hours, I performed a traffic stop at the corner of Catherine Street and Simonton Street, As Harley came on to Catherine Street and placed his skateboard on the roadway to continue riding.

I explained to Harley it was illegal to skateboard on the roadways. Harley responded, "Since when?" I explained I had given him previous warnings and did not want to argue with him. I ordered him to stop so I could issue him a citation. Harley stopped but as I came out of my patrol car, backed away and said he was not stopping, and I was not going to give him a ticket. Harley was very agitated and had the skate board in his hand. I requested back-up. I ordered him to please sit and calm down, pointing to a planter at the corner. Harley backed away refusing to stay or sit. I grabbed his arm and ordered him to stop and sit down while I gave him a ticket or he would be arrested. Harley refused to do either. As I pulled out my handcuffs, Harley Pulled away causing my handcuffs to go flying. As Harley continued to pull away, I directed him to the ground and kept control of him. Officer Mogerley arrived and assisted with handcuffing.

Probable Cause: Clifton Harley committed the act of resisting without violence, by refusing to obey commands during a traffic stop and pulling away as I attempted to handcuff him.

Harley did not sustain any injuries. I sustained minor abrasions to my Left forearm. I washed, applied antibiotic cream and badaged the area.

I issued Harley citation A181AYP for riding a skateboard on the roadway. FSS 316.2065 (11)

I do not have a BWC and the in-car camera did not activate when I turned on the emergency lights. I later noted that I only turned on the front lights, which does not activate the camera system.
