I could see a lone male pulling parked scooters out from the sidewalk and throwing them to the ground. The male did this to three or four scooters. The male was wearing a dark colored shirt, dark shorts, and shoes with a white sole. He had a full sleeve tattoo on his arm.

I walked out to check on the scooters and they had already been picked up and placed back on the sidewalk. The security employee Ray said he just saw the male who did this in the area of the Green Room. I went over and located the male. He matched the male in the video. I placed him into handcuffs and walked him over to my cruiser on Green Street. One more scooter was found to be knocked over by Amigos on Green Street. The owner came out and said no damage was done and started the scooter.

The male identified himself as Aaron Ramos (dob:09/13/1994), by a military identification card. Officer Conaty was also familiar with Ramos from prior Law Enforcement contact.

Fred Bushey came out to my location and showed me the video on his phone and holding that next to Ramos it was identical to him, and all the clothing Ramos had on matched what he was wearing in the video.

Ramos was highly intoxicated, he had a strong odor of intoxicants (alcoholic beverage) coming from his breath and blood shot watery eyes. Ramos provided a PBT of .185% BAC. Due to Ramos actions and intoxication, and I transported him to the U.S. Navy Base at 340 Ely Ave in Key West, to turn him over to the Navy and notify them about what happened.

Upon arrival I met with Security Forces and the Watch Commander Chalecia Miles, Zachary Green, and Victor Mendez. I informed them about what had happened turned Ramos over to them. I spoke with Ramos's boss Chief Khem and informed her about the incident. Ramos was unhandcuffed and U.S. Navy Security Forces placed him into the back of their vehicle.

Ramos started screaming in the back of the vehicle about wanting to kill himself. The door of the vehicle was opened and Ramos started swinging his arms around and got out of the vehicle. Ramos was not following commands. Officer Gillespie, Officer Elsmore, SGT Victor Mendez (U.S. Navy), and I (Ofc. Mogerley), went to handcuff Ramos. Officer Gillespie grabbed his right arm, and I grabbed his left. We turned him and placed him against the military pick up truck and went to handcuff him. Ramos was pulling his arms away and kicking his feet. I placed his left wrist into a handcuff and Officer Gillespie could not gain control of his right arm. Ramos Kicked Officer Gillespie in the right upper thigh and groin area. Officer Elsmore delivered a drive stun (no probes) with his taser. Officer Gillespie took Ramos to the ground to gain better control of him. He was still pulling his arm away and Officer Elsmore drive stuned him again. Ramos complied and he was handcuffed, and sat up.

Upon my arrival, Officer Mogerley had Aaron Ramos detained reference a suspicious incident that occurred on Telegraph Ln. During questioning Ramos was uncooperative with Officer Mogerley. Ramos told Officer Mogerley he would have to kill him to find out any information. Ramos appeared to be intoxicated and the odor of an alcoholic beverage upon his person.

After further investigation, Ramos was an active duty Navy personnel and was stationed at Trumbo Navy base. Ramos was transported to the Trumbo Navy base by Officer Mogerley. Ramos was turned over to the watch commander at the Trumbo Navy base.

Ramos was placed into the back seat of the watch commander's vehicle (unhandcuffed). While in the back seat Ramos became irate and starting hitting the door. When the watch commander opened the door, Ramos began to scream "kill me" and pull away at the other Navy personnel while they tried to restrain him. Officer Gillespie and Officer Mogerley assisted the Navy personnel by grabbing Ramos's arms. Officer Gillespie and Officer Mogerley pinned Ramos against the vehicle to help gain physical control of him. While both officers attempted to place handcuffs on Ramos, his right arm became free from Officer Gillespie's grip. Ramos began to turn toward Officer Mogerley, at that point I conducted a drive stun at Ramos's right pectoral muscle to gain compliance. Officer Mogerley assisted Ramos to the ground while holding his left arm. Ramos continued to resist as I conducted another drive stun to Ramos's rear shoulder muscle. Ramos complied after the drive stun and Officer Mogerley placed him in handcuffs.

KWFD Rescue arrived and transported Ramos to the LKMC to be evaluated. Ramos was cleared and transported to the MCDC.

I had no further involvement with this case.

My BWC was activated for this incident.

On 12/23/2017 at 0303 hours, I (Ofc. Jay Conaty) responded to the 400 block of Greene St. to assist Ofc. N. Mogerley. Ofc. Mogerley advised he had a suspect detained who was seen on video knocking over several mopeds behind Rick's complex (202 Duval St.)

I arrived on scene and saw Ofc. Mogerley, Ofc. A. Gillespie and Ofc. J. Elsmore. Ofc. Mogerley had one adult male in handcuffs who was identified as Aaron Ramos. Ofc. Mogerley spoke to moped owners and did not find any that were willing to pursue charges against Ramos.

Ofc. Mogerley decided to turn Ramos over to NAS security at Trumbo Point. I followed Ofc. Mogerley to Trumbo Point along with Ofc. Gillespie and Ofc. Elsmore. Ofc. Mogerley spoke with NAS security, and Ramos' supervisor responded to Trumbo Point to pick up Ramos. Two Navy personnel sat Ramos in the back of a pickup truck while they spoke to Ofc. Mogerley. Ramos became irate in the pickup truck, and started screaming "kill me, shoot me." Ofc. Mogerley attempted to assist Navy personnel in calming Ramos down. Ramos then got out of the truck, and continued to yell "kill me."

I was across the street from Ramos and the officers when I saw Ramos trying to pull away from the officers' grasp as he continued to yell. I saw the officers direct Ramos to the ground and I heard the sound of a TASER drive stun. Ofc. Mogerely then placed Ramos in handcuffs.

I asked for a supervisor to respond to the scene as well as Rescue.

My BWC was activated for this event.

On 12/23/2017, at approximately 0253 hours, I responded to 202 Duval St. in reference to a suspicious incident.

Upon arrival, I met with Ofc. Mogerley. Ofc. Mogerley had a white male (later identified as Aaron Ramos) in custody, pending the outcome of his investigation. Ramos appeared to be highly intoxicated and had a strong odor of an alcoholic beverage coming from his breath and person. Ramos is enlisted, active duty Navy. Ofc. Mogerley transported Ramos to Trumbo Navy Base with the intention of turning Ramos over to his superiors.

Ofc. Mogerley turned Ramos over to his superiors after arriving on Trumbo Navy base. Ramos superiors placed Ramos inside their vehicle. While inside the vehicle Ramos started yelling and hitting the inside of the door. Ofc. Mogerley and I responded to the vehicle in order to act as back up for the Navy personnel. The Navy personnel opened the vehicle door. Once the vehicle door was opened, Ramos started coming out of the vehicle screaming "just kill me" and swinging his arms. Ofc. Mogerley and I grabbed Ramos and attempted to place his hands behind his back. As I attempted to place Ramos's right hand behind his back, he started to pull away from me and resist arrest. Ofc. Mogerley and I pushed Ramos against the Navy vehicle in an attempt to gain control of him. Ramos pushed himself away from the vehicle and attempted to pull his right arm out of my hand. As Ofc. Mogerley attempted a take down, Ramos turned and looked at me, raised his left leg and purposely kicked me in the upper left thigh/groin area. Ofc. Mogerley conducted a take down, turning Ramos away from me.

Ramos went to the ground and I restrained his right hand behind his back. Ramos continued to try and pull away. Ofc. Elsmore conducted drive stuns on Ramos in order to gain complience. I held Ramos on the ground while Ofc. Mogerley placed hand cuffs on Ramos.

I activated my BWC during the incident. During the incident, my BWC was knocked to the ground.
