

An application was received requesting the removal of **(4) Silver Buttonwood trees**. A site inspection was done on January 25, 2018 and documented the following:

Tree Species: Silver Buttonwood (Concocarpus erectus)


























Diameter: 2.5'', 2.8'' 3.8'', and 3.5'' = 12.6''

Location: 60% (canopy currently under house electrical feeder lines)

Species: 100% (on protected tree list)

Condition: 70% (fair to good) Total Average Value = 76%

Value x Diameter = 9.5 replacement caliper inches

Property owner is re-landscaping the yard once construction on the property is completed. Several trees in the construction area are in the process of being transplanted and ae staged in pots on the property.

Recommendation: Recommend approval of the removal of four (4) Silver Buttonwood trees at 1210 Johnson Street to be replaced with 9.5 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.
