A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING CONCH REPUBLIC INDEPENDENCE CELEBRATION, LLC TO CONDUCT A CONCERT AT THE TRUMAN WATERFRONT AMPHITHEATRE STARTING SATURDAY, APRIL 28, 2018 FROM 6:00 P.M. TO 11:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Manager will be working with the Conch Republic Independence Celebration, LLC in conjunction with the Conch Republic Celebration days between the City of Key West and A.H. of Monroe County, Inc., Key West Cultural Preservation Society, Bourbon Street Pub, and Petronia Street Neighborhood Association; and

WHEREAS, the Conch Republic Independence Celebration, LLC wishes to conduct a concert at the Truman Waterfront Amphitheatre between the hours of 6:00 p.m. to 11:00 p.m. on Saturday, April 28, 2018; and

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida:

SECTION 1. Conch Republic Independence Celebration, LLC is hereby granted permission to conduct a Musical Concert on the date and during the hours stated above, with the following conditions: provided all trash is adequately collected and contained; a guarantee indemnifying the City is executed; and provided the organizations meet additional terms and conditions set forth by the City Manager.

SECTION 2. That pursuant to Section 18-86 of the Key West Code of Ordinances, Conch Republic Independence Celebration, LLC is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area during the event.

SECTION 3. Conch Republic Independence Celebration, LLC will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash container will be used and that they will be placed side by side.

SECTION 4. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
