NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR

AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: That the bid of Ebsary Foundation Company is hereby awarded in an amount not to exceed \$1,126,400.00, as specified in the adjusted response to ITB #18-001, the terms and conditions of which are incorporated herein.

Section 2: That partial funding for this project is budgeted in account 405-7506-575-6300 (Project No. KB1101). Construction costs up to \$617,390.00 are anticipated to be reimbursed to the City through a Local Agency Program Grant through the Florida Department of Transportation. A budget transfer in the amount of \$443,500.00 from the operating reserves account to project KB1101 is hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney, that are consistent with ITB #18-001 and the approval granted herein.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.
