4Q17 Equity Commentary

The fourth quarter of 2017 concluded a strong year for the equity market, by notching a gain of 6.6% for the quarter, and bringing the full year return to 21.8%. The market has now risen for nine consecutive quarters, and volatility continues to be absent. This is now the second longest bull market in duration (106 months), and the third largest in advance (295%). The primary catalyst for the market move in Q4 was the successful conclusion of the tax reform process. This tax cut is larger than the 2003 cut which produced 4% real GDP growth in its first 12 months. The ability of a company to expense 100% of their capital equipment purchases for five years should boost capital spending. The lowering of the US corporate tax rate from 35% to 21% will add to bottom lines, and makes the current valuation of the market look less demanding. While the jury may be out from a perception standpoint with individuals as to whether or not the tax plan is a winner (most believe they will have a tax increase in 2018, but only 5% actually will), US companies will be more competitive abroad, and cash flows will improve. We would certainly be in favor of companies utilizing their new found largesse to invest more in capital projects, but regardless of how they choose to spend their money, shareholders are likely to benefit from larger dividends and potentially larger stock buybacks.

Good fundamentals continue to drive the market, with GDP eclipsing 3% for the last two quarters (even with some slight drag from hurricanes), and expectations are for Q4 GDP to rise 2.8%. Earnings have been strong in 2017 and Q3 earnings grew 6.4%, with revenues increasing 6% as well. Expectations are for Q4 earnings to increase 10.9%, with Energy showing the largest percentage increase as higher oil prices lap easier comparisons. For full year 2017 it now appears that earnings will grow 9.6%, and early reads on 2018 are for earnings growth to accelerate to almost 12%. Infrastructure spending will also be an agenda item the Trump administration tackles in 2018. Historically tax cuts and infrastructure packages are implemented when economic activity is in a lull in order to stimulate demand. With economic activity improving globally in 2017 and employment levels soon to breach under 4%, we will keep a watchful eye on any signs of overheating.

Fourth Quarter Market Recap: The best performing sector for the quarter was Consumer Discretionary (+9.9%), as the apparel, e-commerce and traditional retail segments rallied on the back of strong consumer spending. The brick and mortar retail segment struggled through most of 2017 and the move to e-commerce will continue to provide headwinds to most malls and retailers, but Q4 at least provided a temporary respite for the group. The homebuilding segment was also strong as home prices continued to increase in 2017, and limited inventory of housing has been a positive for builders. Technology also was a strong performer in Q4 gaining another 9%, and maintaining its dominance as the best performing sector for the full year with a gain of 38.8%. The introduction of the new Apple X phone helped to drive Apple shares higher along with many of their suppliers, and semiconductors also performed well in Q4. The tax bill should also be a positive for some of the larger tech companies as they will likely repatriate some of the estimated \$782 billion of unremitted earnings back to the US. Utilities were the worst performing sector in Q4 (0.2%), as bond like proxies suffered in the face of the Fed raising interest rates again in December, and the forecast of another three rate hikes in 2018. Healthcare was also weak in Q4 returning just 1.5%, as both the biotech and pharma segments lagged due to disappointing trial results, and concerns over future reimbursement rates. Very late in the quarter we did see some rotation from the best performing year to date sector (Tech), into the poorest performing area of 2017 (Energy). In December Energy rose over 5% as crude prices hit their highest levels in the last two plus years, while profit taking in the Tech sector caused it to be up under 1% for the month.

Outlook: So after a very good 2017 where do we go from here? It takes very little conviction to expect that volatility in 2018 will be greater than the placid calm we enjoyed in 2017. The biggest market drawdown in 2017 was roughly 3%, and its been over 380 days since the last 5% pullback. Historically low volatility years have been followed by higher volatility, with the average pullback being roughly 12%. Those higher volatility years have also averaged a +5% return for the year.

4Q17 Equity Commentary

Since there really weren't any dips in 2017, perhaps there will be point in 2018 where investors can "buy the dip", and do so with some level of confidence. The economic expansion is maturing, but looks like it should continue. The US economy does not go into recession when corporate earnings are expanding, and they will continue to grow in 2018. The midterm elections in 2018 could cause some uncertainty for the markets as a change in House control might portend a change in economic policy. Since 1962 mid-term election years have averaged an 18% correction. So while some more meaningful pullbacks can be expected, we would tend to view those as opportunities. Economic growth could surprise to the upside with tax changes and infrastructure spend. So far, the Fed has handled the normalization of interest rates (5 rate increases thus far), and the beginning of the downsizing of their balance sheet well. They will likely continue on a measured pace in 2018 with a close eye on how markets are responding to Fed policy, especially with a new Fed Chairman in place. Part of the economic optimism for 2018 stems from the fact that global growth has accelerated as Japan, China, Europe, and India have seen a pickup in activity as well as earnings. It is not just the US pulling the cart any longer. The risk items to monitor in 2018 would seem to center on inflation/interest rates. While the majority of economists still expect GDP to be under 3%, there is a possibility that growth could surprise to the upside if the tax bill spurs capital investment and higher levels of consumer spending. In that environment will the Fed maintain their target of 3 rate increases in 2018, or will they have to move perhaps four times? A faster growing economy and continued tight labor environment could cause inflation to increase faster than expected. Wage inflation is currently just 2.5% but should be heading higher. The key level to watch for is 4%, as this is typically the level when wage inflation serves as a transmission mechanism to broader inflation statistics. Manufacturing indices are stronger across the globe, and inflation at the producer level is increasing, but has not yet been passed on to the consumer. The yield of the 10 year US Treasury will also be a key to monitor.

Rates are still low on an absolute basis, and even with a few more Fed increases should remain palatable. However, a 4% yield would likely be viewed as becoming more troublesome as the Fed could be perceived as behind the inflation curve, and future rate increases could kill the recovery and move the economy into recession. The good news is we are well below those metrics at present, and should remain below for the foreseeable future.

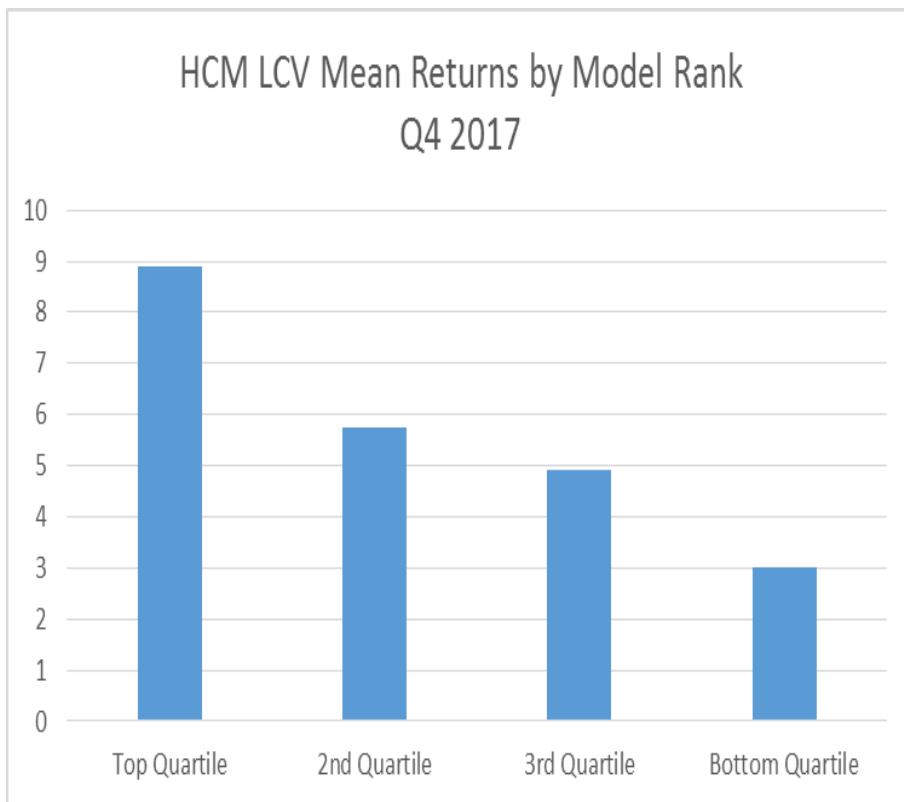
Of course, no market discussion would be complete without addressing valuations. The market is currently selling at 18.4X forward earnings, and is above the 5 year average of 15.8X. We view this as slightly stretched, but still well below the levels of the Tech bubble peak in 2000 when the median stock sold at a valuation of 31X earnings, versus 19.7X today. Even with the big move in 2017, this has still been an unloved bull market, as net domestic equity flows are slightly negative in aggregate over the last nine years. The "dips" that may occur in 2018 are likely to be shallow and of limited duration, as investors who have missed a lot of the bull run commit money to the pullbacks. And while central banks are now beginning to move toward moderate tightening, monetary conditions are still accommodative. We do not expect a repeat of 2017 in terms of market returns, and 2018 could be a year when the economy outperforms the markets; but with a solid economic foundation and a growing earnings stream, we would continue to expect positive returns in 2018.

4Q17 Core Value Equity Portfolio Manager Commentary

Returns were healthy for the quarter and the entire year. The large cap value index advanced 5.33% for the quarter with Financials continuing their leadership in the face of rising interest rates. Our model was predictive for the quarter as the chart below shows with our top quartile ranked stocks outperforming the bottom quartile by nearly 6%.

Looking forward into 2018, it is likely that the changes to corporate tax rates will have a significant one time adjustment on some companies that could impact our modelling in the first quarter. Nonetheless, as the impact becomes more understood by the analyst community, we would expect our modeling to adjust rapidly.



At the time of this writing, the portfolios remain overweight Technology, Materials, Industrials and Financials, reflecting the preference for cyclical exposure in our model. Conversely, we remain underweight Staples, Discretionary, Health Care, Utilities and Real Estate, those sectors that are historically more defensive or interest rate sensitive.

4Q17 Large Cap Growth Portfolio Manager Commentary

Stock markets continued higher with Large Cap Growth leading over Value for another quarter. Indicators favoring a passage of a Tax Reform Bill fueled expectations of higher earnings, stock buybacks and larger dividends as a result of lower tax rates and a repatriation of overseas funds. The current bull market run is now the 2nd longest in terms of duration. The occasional geo-political scares have been irrelevant as the markets have continued to march higher. The Russell 1000 Large Cap Growth Index returned 7.86% for the last quarter of 2017. The strategy itself returned 7.67% for the quarter, underperforming the benchmark by only 19 bps.

Performance Attribution

The best performing sectors for the quarter were Consumer Discretionary (+10.7%) and Producer Durables (+10.2%) as consumers spent more than expected in a healthy US economy. The portfolio was positioned slightly overweight to the Consumer Discretionary sector but stock selection detracted some of the positive effects of the overweight. Conversely, the portfolio was underweight Producer Durables but stock selection contributed positively to performance in the sector. All sectors had positive performance for the quarter with the Health Care sector being the only laggard at +0.8%. Overall, Stock selection detracted from performance this quarter as the model selected stocks that underperformed the benchmark but the underperformance was relatively mild.

Outlook

For the near term, markets don't look to be slowing down with companies getting a final boost from tax reform. With higher earnings expectations, stock buybacks and higher dividends, markets should continue to trend upward although the pace may slow from the 30.2% return of 2017 for the Russell Large Cap Growth. We utilize factors built on fundamentally sound principles of value, growth and technical indicators that have been proven to outperform over time and we continue to believe our model will be effective going forward.

4Q17 Fixed Income Portfolio Manager Commentary

On December 13th, as expected, the Federal Reserve hiked short term interest rates another 25 basis points. The increase was the third time this year and the Fed will continue to reduce the central bank's balance sheet by allowing additional securities to roll-off, another form of tightening financial conditions. The Federal Reserve continues to hike interest rates as inflation runs below the Fed's mandate of 2%, this lack of inflation was a key reason why two members of the Fed (Kashkari and Evans) voted against raising interest rates in December. The Fed is projecting three additional rate increases in 2018 unchanged from previous projections.

The significant news during the quarter was related to tax policy from the new administration which is expected to add at least 1% to GDP in 2018. The new tax code will have a profound impact on the corporate bond market. In most cases, issuing debt has been a cheaper cost of capital compared to selling equity. After the lowering of corporates taxes and placing a cap on the corporate interest deduction, we project total supply of debt to decline year-over-year as issuing debt has become a less attractive option. According to Bank of America, proposed legislation will reduce the supply of investment grade bonds by as much as 17% next year. As part of the new tax legislation, US multinational companies could bring back some of the estimated \$2.6 trillion in business profits held overseas which could spur M&A, stock buybacks and deleveraging. Additionally, the municipal bond market will be impacted by the new federal tax bill. The drop in the corporate income tax rate to 21% from 35% will make municipals bonds less attractive to banks and insurance companies who are natural buyers of the asset class.

Most fixed income indexes exhibited positive returns during the fourth quarter of 2017. The Bloomberg Barclays US Gov/Credit index increased +0.49% during the quarter and ended 2017 up +4.00%. The Gov/Credit index outperformed the Bloomberg Barclays Aggregate, which was up +0.39% during the quarter. The Bloomberg Barclays Aggregate finished the year up +3.54%. The Gov/Credit index has a longer duration profile compared to the Bloomberg Barclays Aggregate which was the main reason for the outperformance. Long dated assets continued the trend and outperformed all other parts of the Treasury curve in 2017 as the yield curve flattened. The Bloomberg Barclays US Intermediate Gov/Credit index declined -0.20% during the quarter and was up 2.14% in 2017. Active management in the bond market was tested this year; managers that have been waiting for long term rates to go up were proven wrong. The best performing area of the market, by a wide margin, was long dated securities. Domestic and foreign investors gravitated towards the long bond as global inflation remains stubbornly low. As we discussed during the last quarterly letter, a central theme in the bond market in 2017 has been the flattening of the Treasury curve. As the Federal Reserve has raised short term interest rates, long bond yields have not followed the same path. From a performance standpoint, risk across fixed income securities continued to be the clear winner, as corporate bonds outperformed treasuries, agencies and mortgages. During 2017, the lowest quality rating within investment grade (BBB) outperformed AAA investments during the year (+7.45% vs. +2.41%). Top performing sectors during the year included: Metals & Mining (+15.2%), Refining (+10.98%) and Subordinated Bank Debt (+9.4%). Corporate bonds have held up extremely well in 2017 in light of the market skepticism about economic growth prospects. Company leverage has declined across the industry providing better fundamental support for investors. Additionally, company leverage should decline further after the tax reform is implemented. Global speculative-grade defaults are projected to finish 2017 at 2.8% and Moody's is forecasting the default rate to decline to as low as 1.8% in 2018.

4Q17 Fixed Income Portfolio Manager Commentary

2018 will be an interesting year in the bond market. Several Wall Street firms believe the Fed will raise short term rates four times in 2018 which might be justified as the Atlanta Fed is predicting 3% growth next year. \$1.3 trillion of US Treasury issuance is forecasted in 2018 which is the most since 2010. If the tax reform stimulates growth and inflation, long dated Treasury assets will be re-priced accordingly.

As short term rates have risen over the past year, the market has presented a wide array of investment options for investors that have been on the sidelines waiting for a better return profile in fixed income.

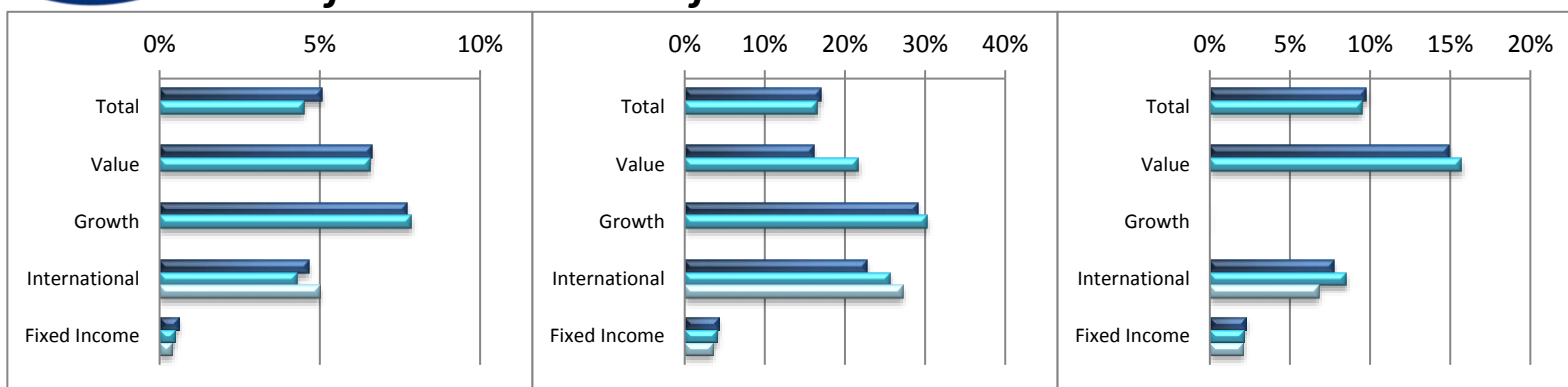

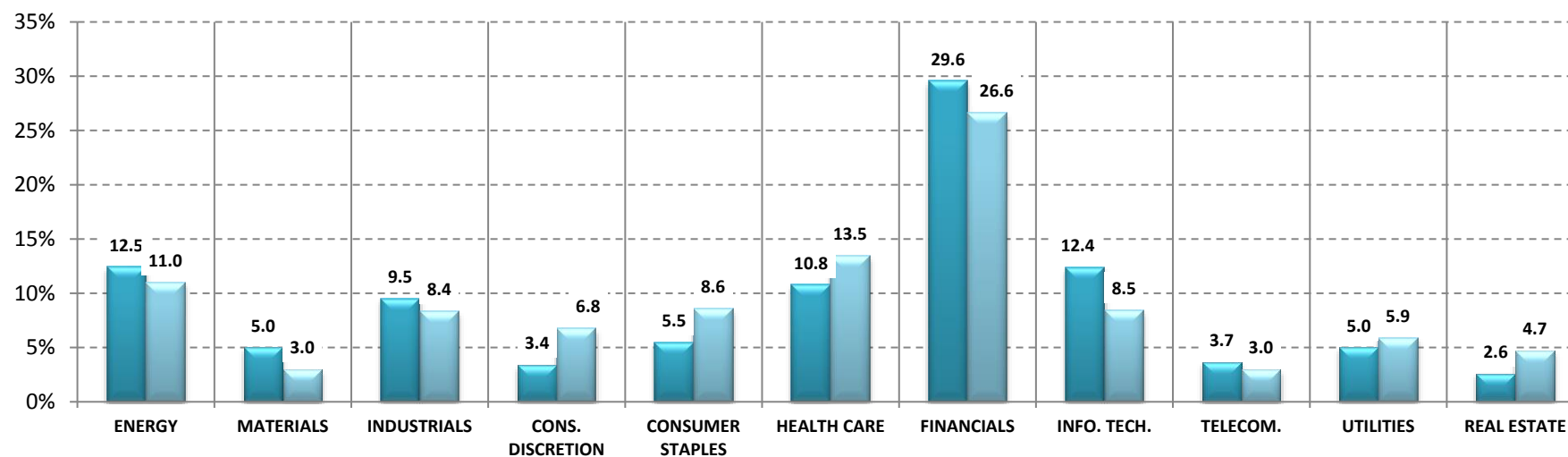

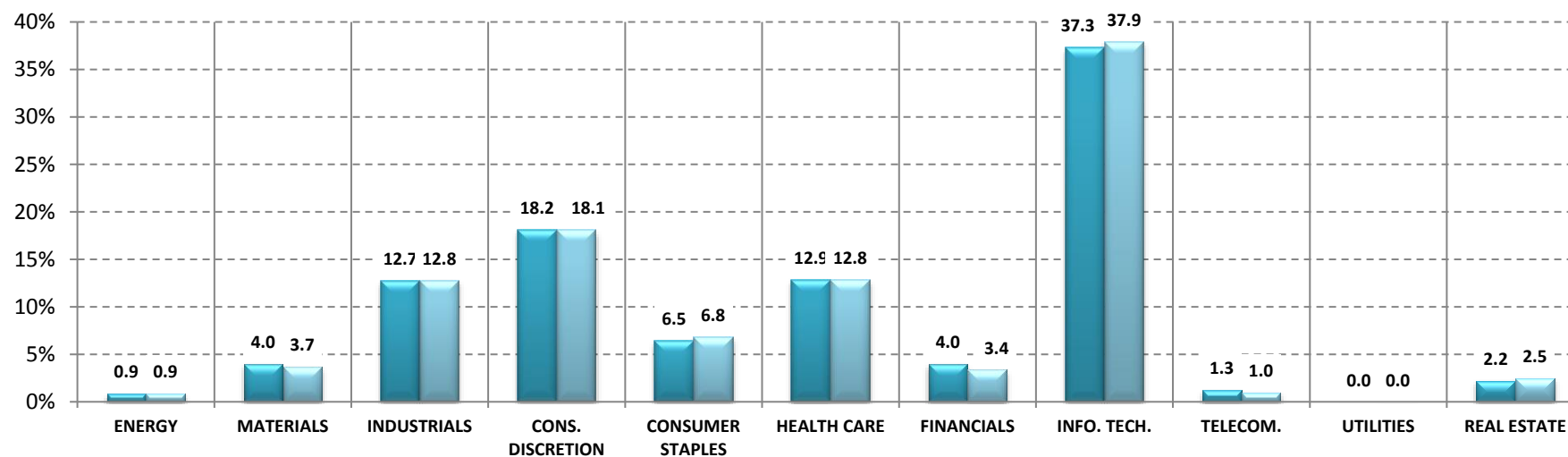
Domestic Equity Sector Allocation vs. R1000V



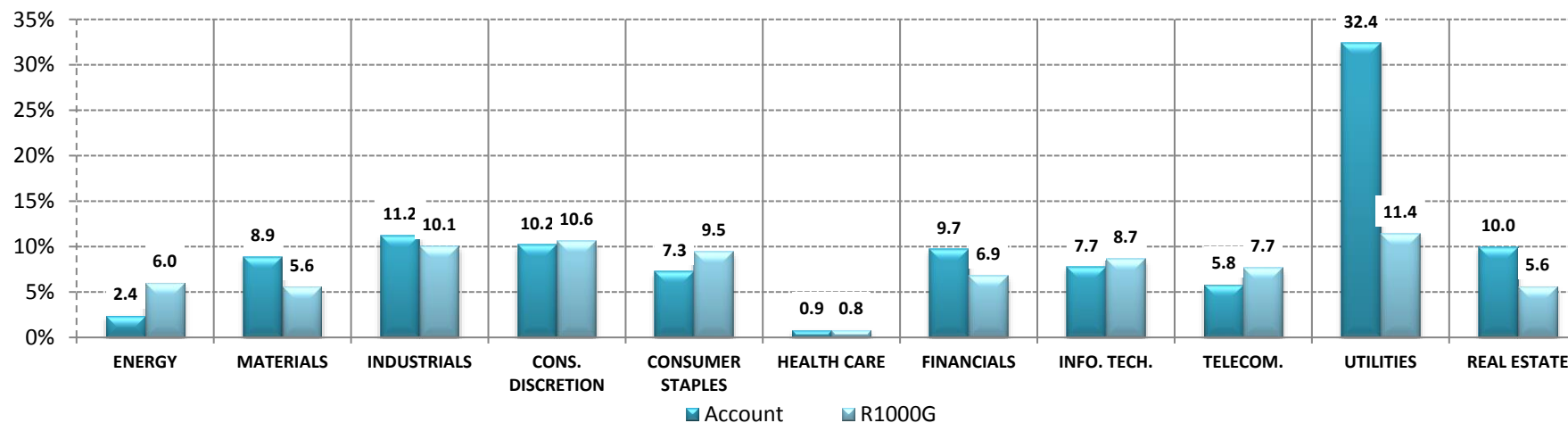
Domestic Equity Quarterly Sector Returns vs. R1000V



Domestic Equity Sector Allocation vs. R1000G

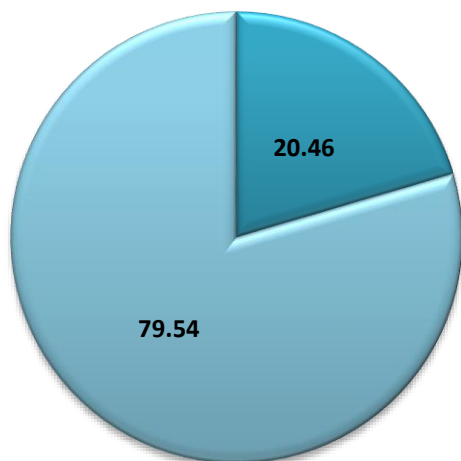


Domestic Equity Quarterly Sector Returns vs. R1000G

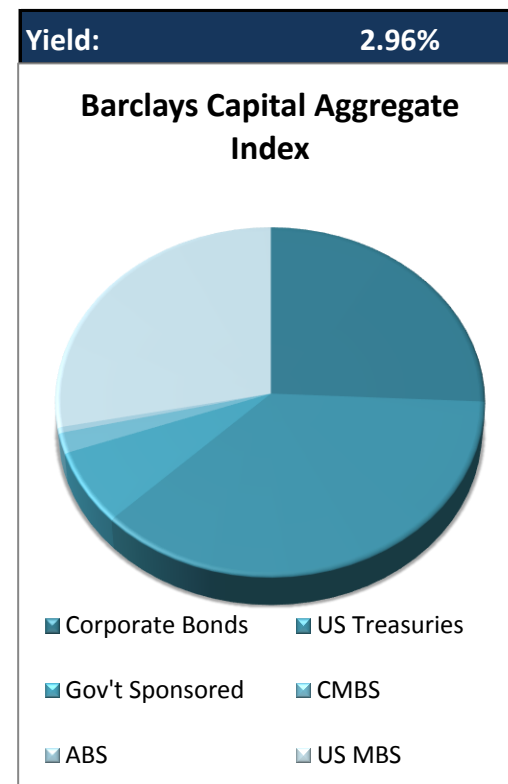

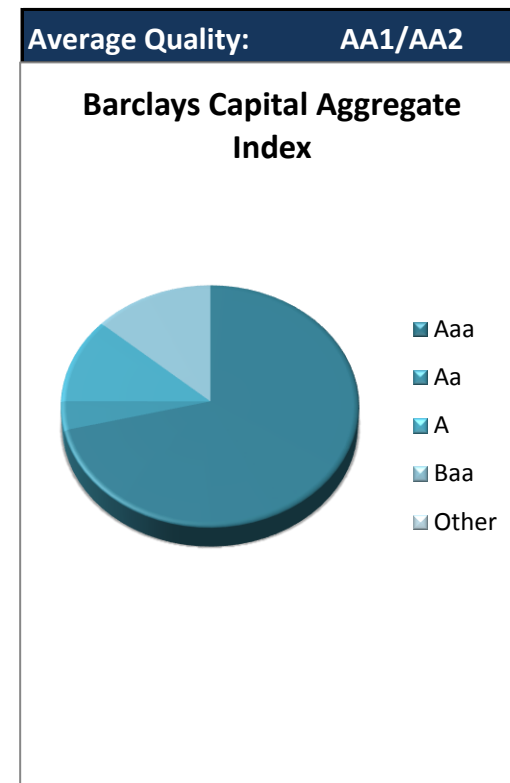
Bond Quality Allocation

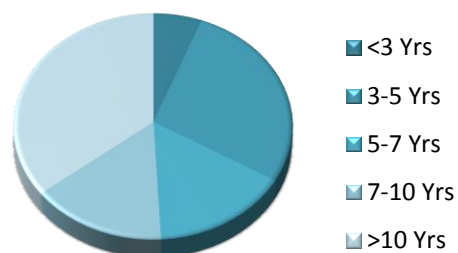

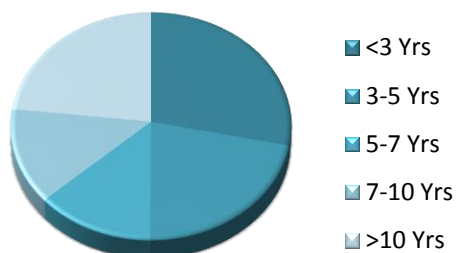

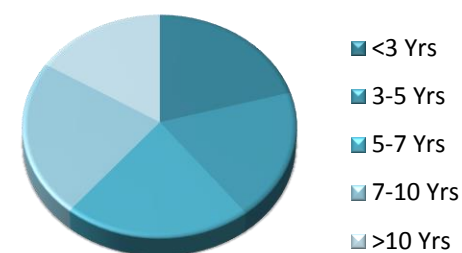
Barclays Capital Government/Credit Index

Barclays Capital Aggregate Index

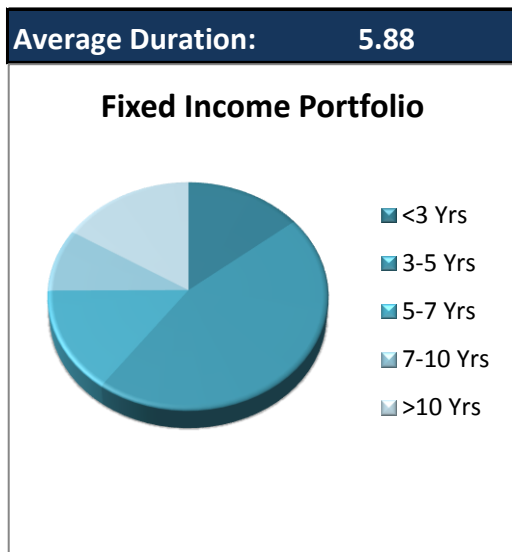

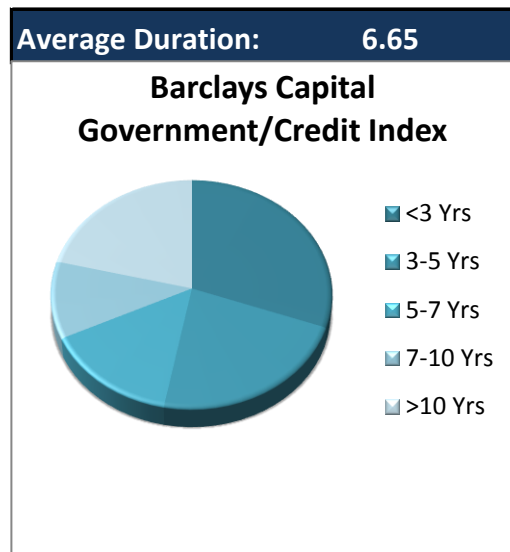

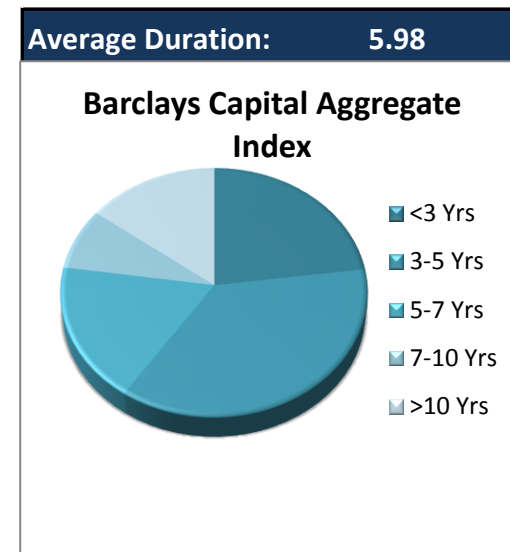
Duration Allocation



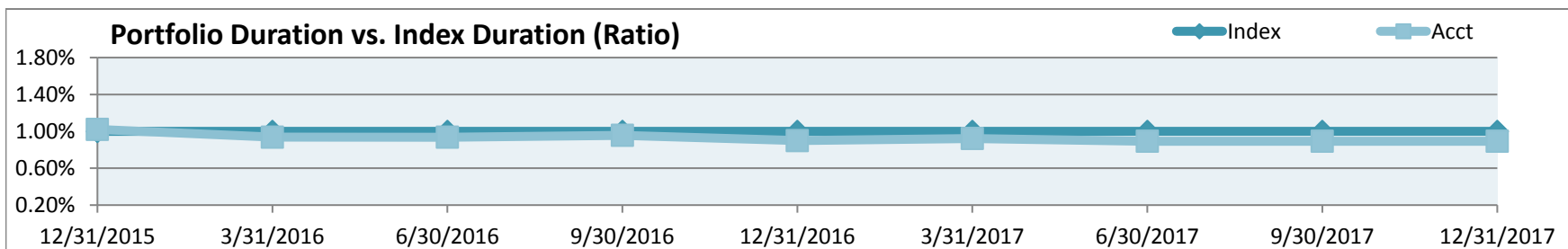
