A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A PURCHASING EXCEPTION AS ALLOWED UNDER SECTION 2-797(4)(b) OF THE CITY'S CODE OF ORDINANCES, BEST INTERESTS OF THE CITY, FOR PROCUREMENT OF TECTUM ACOUSTICAL PANELS FOR THE FREDERICK DOUGLASS GYM IN AN AMOUNT NOT TO EXCEED \$22,600.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City staff obtained price quotes for Tectum Acoustical Panels from three supplier/distributors, and the quote from Foundation Building Materials (FBM), was the lowest responsive proposal; and

WHEREAS, pursuant to City Code Section 2-797(4)(b), the City Manager finds that exceptional circumstances exist to exempt a purchase from the competitive bid requirements in the best interests of the City, and recommends purchase of the acoustical panels from FBM in an amount not to exceed \$22,600.00, so that the project can be completed in an expeditious manner, with minimal impact on the gym activities schedule; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the City Commission, in accordance with Section 2-797(4)(b) of the Code of Ordinances, hereby approves the procurement of acoustical panels for the Frederick Douglass Gymnasium in an amount not to exceed \$22,600.00, from Foundation Building Materials.

Section 2: That sufficient funds for this procurement are available, from the Douglass Gym project account 303-1900-519-6200 (Project PR 1206).

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
