



An application was received requesting the removal of **(1) Black Olive tree**. A site inspection was done on February 28 and March 16, 2018 and documented the following:


Tree Species: Black Olive (Bucidia beceras)
















Diameter: 25.7" - 24" = 1.7"

Location: 60% (impacting fence on property line, close to structure)

Species: 0% (on the not protected tree list)

Condition: 70% (fair, canopy with some storm damage)

Total Average Value = 43%

Value x Diameter = 0.7 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Black Olive tree at 1212 Watson Street to be replaced with 0.7 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.






