On 2/22/18 at approximately 2130 hours, I, Officer K. Hansell was dispatched to the 3200 block of Northside Dr for a medical call where a male had fallen from his bicycle and appeared to be having a seizure.

Upon arriving I observed a white male with facial injuries physically fighting with Fire/Rescue. The male was taken to the ground by myself and Officer T. Calvert due to his attempts to pull away from Fire/Rescue. The male had lacerations to his face and head area and was bleeding from his mouth. The male was chemically restrained by Fire/Rescue and taken to Lower Keys Medical Center for evaluation. The male was later identified as Nicholas Aydent via his Florida ID card after transport to the Lower Keys Medical Center. It appears Nicholas had a seizure and fell from his bike somewhere in the 3200-block of Northside Dr. He could not tell me exactly wherehe fell.

Photographs were taken of Nicholas's injuries at the hospital. Nicholas was provided the report number along with my name and business card at the hospital.

No photographs were taken of the actual scene where Nicholas fell from his bike as upon arriving the bike and Nicholas had already been moved. No witnesses were located at the scene.

Nicholas's bicycle was transported to The Key West Police Station by Officer S. Standerwick for safekeeping.
