away from Ofc Perez. I quickly exited my car to assist Ofc Perez with Poljak.

After the warrants were confirmed Ofc Perez and I tried to place Poljak in handcuffs. Poljak appeared intoxicated and was not listening to my verbal commands. Poljak was actively resisting by being tensed up and not moving his hands for me to handcuff him. Poljak kept repeating he wanted to get "tased". I attempted several times to gain control of Poljak's hands, but he kept pulling away from me and trying to walk away. After multiple unsuccessful attempts to handcuff Poljak due to him actively resisting, I deployed my agency issued Taser to gain control of Poljak. Ofc Perez handcuffed Poljak after he was on the ground.

EMS personnel arrived on scene and medically cleared Poljak. I transported Poljak to the Monroe County Detention Center without further incidents.

My BWC video and Taser video will be uploaded to the COBAN server as evidence.

Poljak violated F.S.S. 843.02 (Resisting officer w/o violence) by actively resisting arrest as I was trying to handcuff him.

On Sunday, March 18, 2018, approximately 0215 hours, I officer Perez was patrolling on foot the 100 block of Duval Street.

I observed a white male, sleeping on the sidewalk, later identified as Richard Stan Poljak (DOB 01/10/1975). I ran Poljack on The Key West Police Communications Department on channel 2. Communications Department advised me, Poljack had a warrant from MCSO.

I asked Poljack to turn around and place his hands behind his back. Poljack did not comply with my lawful command and tried walking away from me. At the time Officer Valdez-Marrero, arrived on scene. Officer Valdes-Marrero and I advised Poljack to comply, or he would be tased.

Poljack continue to resist and continue to not comply with our verbal command. Poljack tensed his arms pulling away from us. Officer Valdez-Marrero tased Poljack. Poljack then took a couple of steps away from us, I closed the space between him and I, and I held him as he went to the ground. I proceed to handcuff Poljack and he continued to resist by not bringing his arms behind his back. I had to asked Poljack several times to stop resisting, until I was able to secure him in handcuffs.

My BWC was on during the incident. I submitted the BWC footage into the Key West Police Department DPM server.

I removed the Taser probe off Poljack body. One probe hit the center of his chest and the second probe pierced papers he had on the left pocket of his shirt. Key West Rescue unit #2 arrived on scene and attended and medical cleared Poljack.///END OF REPORT///
