WHEREAS, Hurricane Irma made landfall in Key West and Monroe County, Florida, on September 10, 2017, causing extensive damage and generating large quantities of debris on public property; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Federally-Funded Subaward and Grant Agreement" in the initial amount of \$2,076,816.35 for DHS/FEMA Grant

to Local Government for Debris Removal, Emergency Protective Measures and Repair or Replacement of Disaster Damaged Facilities (Contract Number: Z0029; FAIN: 4337DRFLP0000001; Sub-Recipient's PA ID/FIPS Number: 087-36550-00) pass-through administered by the FDEM is hereby accepted.

Section 2: That authorization is hereby granted for the City Manager to execute the Subaward and Grant Agreement Contract and related documents, upon advice and consent of the City Attorney.

Section 3: That authorization is hereby granted for the City Manager to approve and execute subsequent amendments to the Subaward and Grant Agreement Contract, which may adjust to increase grant funding allocations, upon advice and consent of the City Attorney.

Section 4: That necessary budget amendments and transfers are hereby authorized to reflect receipt and expenditure of grant funds.

Section 5: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
