A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING PURSUANT TO SECTION 2-797(4)(b) OF THE CODE OF ORDINANCES THE PROCUREMENT OF ONE SHADOW FOUR HORSE GOOSENECK TRAILER WITH ACCESSORIES FROM SHADOW TRAILER WORLD, IN AN AMOUNT NOT TO EXCEED \$37,986.50, FOR USE BY THE KEY WEST POLICE DEPARTMENT MOUNTED UNIT; AUTHORIZING THE USE OF FUNDS FROM THE MOUNTED UNIT DONATION ACCOUNT FOR THIS PURCHASE; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City staff obtained three price quotes for four-horse trailers, and determined that the price quote from Shadow Trailer World was responsive and the lowest amount; and

WHEREAS, funds donated for use by the Mounted Unit of the KWPD will be used for this purchase, and pursuant to City Code Section 2-797(4)(b), the City Manager finds that exceptional circumstances exist to exempt a purchase from the competitive bid requirements in the best interests of the City; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the procurement of one Shadow Four Horse Gooseneck Trailer with Accessories from Shadow Trailer World, in an amount not to exceed \$37,986.50 is hereby awarded pursuant to Section 2-797(4)(b) of the Code of Ordinances, for use by the Key

West Police Department Mounted Unit.

Section 2: That the use of funds from the Mounted Unit Donation Account 001-2101-521-6400/GF21011701 is authorized for this purchase.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
