A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF BURKE CONSTRUCTION GROUP, INC. FOR THE RESOD OF POINCIANA AND HORACE O'BRYANT FIELDS IN ACCORDANCE WITH THE TERMS SPECIFIED IN ITB #18-030 IN AN AMOUNT NOT TO EXCEED \$398,400.00; AUTHORIZING THE USE OF BP SETTLEMENT FUNDS FOR THIS PROJECT; AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE CONTRACT DOCUMENTS CONTAINED IN THE BID PACKAGE ON BEHALF OF THE CITY OF KEY WEST; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on May 16, 2018, 2014 two bids were opened in response to ITB #18-030, for Resod of Poinciana and Horace O'Bryant Fields, and both of the bids were responsive;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Burke Construction Group, Inc. for the Resod of Poinciana and Horace O'Bryant Fields in accordance with the terms specified in ITB #18-030 is hereby awarded in an amount not to exceed 398,400.00.

Section 2: That funds received from the BP Oil Settlement, account 102-7201-572-4600, are authorized to be used for this project.

Section 3: That the City Manager is authorized to execute a contract in substantial conformance with the contract documents contained within the bid package on behalf of the City of Key West upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
