Hello Karen,

I am the property owner of 630 Dey Street Key West Florida and am requesting permission to remove the Japanese Blueberry tree.

The tree roots penetrated the irrigation pipes and caused water leaks for a month. The problem went unnoticed because the leak was underground and only came to our attention when John, an agent of FKAA, called on 9 March 2018 to let us know that the water meter was running continuously.

FKAA shut off the meter to the garden until we are able to contain the leak. Blue Island, the irrigation installers, told us that they can not proceed to resolve the problem until this tree is removed. The repairs have not yet even been quoted, let alone accepted or performed, so we have no plumbing receipts to show you. If helpful, Alistair will be able to show you the increased costs of maintaining the plantings manually while the automatic irrigation is out of order.

I attached copies of recent water bills including that of 8 March 2018 when the bill jumped to over \$1,200 for the month when the leak occurred.

Please let me or Alistair Closs know what more we can tell you.
