On 5/12/18, I was at the Monroe County Correctional Center and Officer Dantu was bringing in a combative male that he had arrested. The Jail Sgt. requested Officer Marrero and I help him get the male into a restraint chair.

The male was in the back of Ofc. Dantu's car and he was laying down and refusing to get out. We lifted him out of the car and placed him onto the ground. The male was not moving and I gave him a sternum rub, and he became alert. He started to try to kick us and roll around. We restrained him on the ground. The jail Sgt. brought the restraint chair and we moved him into the chair. As we were attempting to strap him in he was trying to kick Ofc. Marrero, I delivered a knee strike to his right leg to gain compliance. The male was actively resisting us by pulling his body away and trying to prevent us from restraining him in the chair. He was screaming things like "kill me" and "shoot me". I had to push his waist down on the chair to get the belt attached, and hold his upper body down while he was trying to use his upper torso to hit us. The male was strapped down to the chair and he was brought into booking.

The male was later transported in the chair to the Lower Keys Medical Center. I assisted in bringing him down to the ambulance, and putting him into the ambulance. He was left in the restraint chair while transported to the emergency room to prevent injury to himself, medical staff and Officers.

This ends my involvement in the case.
