An application was received requesting the removal of **(1) Sapodilla tree**. Several site inspections were done and documented the following:

Tree Species: Sapodilla (Manilkara zapota)








































Diameter: 36.3"

Location: 80% (backyard tree)

Species: 100% (on protected tree list)

Condition: 60% (fair overall, some canopy damage due to hurricane)

Total Average Value = 80%

Value x Diameter = 29 replacement caliper inches

Note: Property owner and representative had a concern regarding an uplifted root and a potential lean to the tree trunk. Old photos indicate the tree trunk has always had a lean. Inspections document that all the roots except for one surface root are still in place in the ground.

The neighbor recently dug a large hole in the backyard and installed a pool/spa. The fill from the work was piled against the base of the sapodilla tree. It is thought that during this construction work the root was uplifted.

The canopy of the tree was properly trimmed after the hurricane (with permits). Due to the lack of absolute evidence of a safety threat of a leaning tree with uplifted and unsecured roots, denial of the removal permit is recommended. It is recommended that a permit be issued to cut/remove the uplifted root (permit required due to the size of the root and closeness to the main trunk).

I looked at the tree and root this morning. If that root is coming from the tree it is not a primary structural root. It could be one of the many other roots associated with the tree. I do not think that tree is a hazard and I see no evidence that it is going to fall. All of the other roots including the main structural roots appear to be in tact and stable. I do not recommend removal of the tree but I do recommend cutting of that one root, if it is attached, and trimming of the canopy for balance.

Right now I have the application listed as removal of the tree for the August 14 Tree Commission meeting. Let me know if there are any changes to that request.

There are also some serious tree abuse issues with this area......digging in the critical root zone, Lack of tree protection, trunk damage to the frangipani.......
