A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A PROCUREMENT OF PROFESSIONAL SERVICES PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES, PROCUREMENTS UNDER GOVERNMENT CONTRACT, FROM TINDALE OLIVER & ASSOCIATES, INC. (TINDALE) TO PREPARE THE CITY'S FDOT-COMPLIANT 10-YEAR TRANSIT DEVELOPMENT PLAN (TDP), IN AN AMOUNT NOT TO EXCEED \$130,000.00 TO COMMENCE IN FY 18-19; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Florida Department of Transportation requires the City to submit a 10-Year Transit Development Plan (TDP), along with 5-year major updates, to support the development of an effective multi-modal transportation system for the State of Florida; and

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, the City of Key West finds that the procurement of professional services from Tindale Oliver & Associates by piggybacking, pursuant to Code of Ordinances section 2-797(3), and Section 25(b) of the government contract between Tindale and River to Sea, the Transportation Planning Organization for Volusia County and the developed areas of Eastern Flagler County, would be a cost-effective method to procure the City's Transit Development Plan; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a procurement in an amount not to exceed \$130,000.00 for professional services by Tindale Oliver & Associates, Inc., pursuant to Section 2-797(3) of the code of ordinances, procurements under government contract, for an FDOT-compliant 10-Year Transit Development Plan, is hereby approved to commence in FY 18-19.

Section 2: That adequate funding for this project has been requested for FY 18-19 in account 411-4401-544-31.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
