A RESOLUTION OF THE CITY COMMISSION OF THE OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT DATED SEPTEMBER 7, 2018 APPROVED BY THE CITY MANAGER AS PROVIDED FOR SECTION UNDER 2-797(2) OF THE CODE ORDINANCES, AUTHORIZING THE PURCHASE OF 12" EFFLUENT RISER PIPE FROM FERGUSON WATERWORKS IN AN AMOUNT NOT TO EXCEED \$9,000.00, AND A TASK ORDER IN AN AMOUNT NOT TO EXCEED \$41,344.80 FOR CHARLEY TOPPINO & SONS, INC. TO INSTALL THE EFFLUENT RISER PIPES AT PUMP STATION C (COMBINED TOTAL 50,344.80); AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 15-021, the City Commission approved a three-year General Utilities contract with Charley Toppino & Sons, Inc.; and

WHEREAS, one of the two 12-inch effluent riser pipes failed, and the second pipe is showing signs of corrosion, therefore it is necessary and cost-effective to simultaneously replace the two 12-inch effluent riser pipes at Pump Station C before a catastrophic failure can occur; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to authorize and procure the necessary task order to ensure prompt purchase and installation of stainless steel 12-inch effluent riser pipes to replace the two pipes in need of immediate replacement; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached emergency task order dated September 7, 2018 by the City Manager, pursuant to section 2-797(2) of the Code of Ordinances, for procurement and installation of 12" effluent riser pipes at Pump Station C, is hereby approved, to Charley Toppino and Sons, Inc in an amount not to exceed \$41,344.80 and Ferguson Waterworks in an amount not to exceed \$9,000.00 (project combined total of \$50,344.80).

Section 2: That this task order will be paid from budget line 401-3504-535-4600, repairs and maintenance, and any necessary transfers are hereby authorized.
