A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING BACKDECK, LLC D/B/A MARY ELLEN'S BAR TO CONDUCT AN EVENT AS A FUNDRAISER FOR THE WESLEY HOUSE ON WEDNESDAY, DECEMBER 5, 2018 FROM 8:00 A.M. TO MIDNIGHT; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF APPLEROUTH LANE BETWEEN DUVAL STREET & WHITEHEAD ON WEDNESDAY, DECEMBER 5, 2018 FROM 8:00 A.M. TO MIDNIGHT; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 8:00 A.M. TO MIDNIGHT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Backdeck, LLC d/b/a Mary Ellen's Bar wishes to conduct an event as a fundraiser for the Wesley House on Wednesday, December 5, 2018 on Applerouth Lane between Duval Street & Whitehead Street.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida;

SECTION 1. That Backdeck, LLC d/b/a Mary Ellen's Bar are hereby granted permission to conduct a fundraiser for the Wesley House on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager; and that 25% of gross revenue or \$1,000.00, whichever is greater, shall be donated to the non profit.

SECTION 2. That Backdeck, LLC d/b/a Mary Ellen's Bar is hereby granted permission for the closure of Applerouth Lane between Duval Street & Whitehead Street on the date and during the hours stated above.

SECTION 3. That Backdeck, LLC d/b/a Mary Ellen's Bar is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, Backdeck, LLC d/b/a Mary Ellen's Bar is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 5. That Backdeck, LLC d/b/a Mary Ellen's Bar will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 6. This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
