A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF A THREE YEAR SERVICE CONTRACT RENEWAL FROM PHYSIO-CONTROL, INC. FOR FIVE (5) LIFEPAK 15 CARDIAC MONITORS PLUS ACCESSORIES AS A BRAND NAME PRODUCT, ON A SOLE SOURCE BASIS PURSUANT TO SECTION 2-797(1) FOR BRAND NAME ITEMS, PURSUANT TO CITY CODE SECTION 2-844(a) and (b) FOR THE KEY WEST FIRE DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$23,209.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

WHEREAS, all City ambulances are equipped with a functioning cardiac monitor, as required by Florida Department of Health Regulations; and

WHEREAS, Physio-Control, Inc. is the only source City staff has been able to identify to provide maintenance and repair service for the Physio-Control LifePak 15 Cardiac Monitors currently used by the Key West Fire Department, which are essential for patient care in City ambulances; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of a three-year service contract renewal from Physio-Control, Inc., Inc. is hereby authorized pursuant to section 2-797(1) for brand name items, pursuant to City Code sections 2-844(a) and (b) for the Key West Fire Department, in an amount not to exceed \$23,209.00 (to be paid in three annual installments of \$7,736.33).

Section 2: That funding for the FY19 annual service contract installment is budgeted in in EMS Repairs and Maintenance account #001-2601-526-4600.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
